#### Winning Over the Roberts Court in Indian Law Cases: A Continuing Dialogue

With the decision in *Plains Commerce Bank v. Long Family Land & Cattle Co.*, 128 S.Ct. 2709 (Jun. 25, 2008), issued last term, Chief Justice Roberts has assumed a prominent role in determining the future direction of Indian law jurisprudence before the U.S. Supreme Court. This panel will examine, from a variety of perspectives, what we can learn about the Roberts Court generally, and the potential direction of Indian law, from the first major Indian law case of the Roberts era.

Current tax policy both constrains tribal action and provides exciting opportunities for growth and development in Indian Country. Congress is currently working to address tax provisions that disadvantage tribes – such as inequitable rules regarding tax exempt bond issues – while also working to reauthorize innovative programs such as the New Market and Renewable Energy Tax Credits. This panel will examine the prospects of policy change with the coming change in administration and a new Congress, as well as strategies for the effective use of economic development tools grounded in tax policy.

#### **Advocating Effectively Under New Lobbying and Ethics Rules**
