Douglas Nash, Director – Center for Indian Law & Policy at Seattle University Law School. A member of the Nez Perce Tribe, Nash served as Chief Counsel for the Nez Perce Tribe for 10 years and has been practicing Indian law for nearly 40 years.

Philip E. Cutler, Principal -- Cutler Nylander & Hayton (Seattle). Mr. Cutler has represented clients in commercial and business litigation, mediation and arbitration for over 35 years. For the last 20 years, a significant portion of his practice has involved service as mediator, arbitrator and special master in commercial, business and securities disputes both privately and those administered by organizations such as AAA and FINRA.
