**ORDER SETTING HEARING ON EMERGENCY MOTION FOR TEMPORARY  
RESTRAINING ORDER AND TEMPORARY INJUNCTION**

This matter comes before the Court upon the request of Plaintiffs, Gaughan Gaming-Native Lights, LLC and Gaughan Gaming-Tonkawa, LLC (collectively "Gaughan Gaming") to set a hearing on Gaughan Gaming's Emergency Motion for Temporary Restraining Order and Temporary Injunction filed March 21, 2011 (the "Emergency Motion"). For cause shown in the Emergency Motion and the attached Affidavit of John Gaughan, the court directs as follows,

IT IS ORDERED that a hearing on Gaughan Gaming's request for temporary restraining order enjoining the Tonkawa Tribal Gaming Commission (the "TTGC") from conducting summary proceedings with regard to Gaughan Gaming's Management Contract License (as defined in the Emergency Motion) shall be conducted on the 25th day of March, 2011 at 10:00 a.m./~~p.m.~~ before the Honorable Philip Ross, Kay County Courthouse, ~~Ponca City~~/Newkirk, Oklahoma.

IT IS FURTHER ORDERED that at the hearing set above, the Court shall set a hearing at some later date on Gaughan Gaming's request for temporary injunction enjoining the TTGC and the Tonkawa Tribe of Indians of Oklahoma as set forth in the Emergency Motion.
