DECLARATION OF
WAYNE SCHAKEL

Wayne Schakel declares as follows:

1. I am of legal age, am competent to make this Declaration, and do so based upon personal knowledge and in my capacity as a police officer for the Tulalip Tribes.
2. I am a duly commissioned Tulalip Tribes Peace Officer, on the Safe Trails Drug Task Force, and am cross-commissioned as a Snohomish County Deputy Sheriff. I am also cross-commissioned with the FBI and as a Special Deputy U. S. Marshal. I have over 7 years of law enforcement experience at this time, and am a graduate of the Washington State Criminal Justice Training Commission Law Enforcement Academy (Basic). I have completed 80 hours of Specialized Drug Training for Investigators. I have completed specialized Public Safety/Law Enforcement training that addresses drug enforcement, drug interdiction, trafficking, hidden compartments, surveillance and conspiracies. During my law enforcement career, I have investigated or jointly investigated crimes that include, but are not limited to, drug violations, burglary, homicide, rape, assault, theft, fraud and criminal traffic offenses.

1 4. I started the investigation that led to the arrest of Ms. Youde in January, 2010 when I
2
3 was asked to follow-up on a tip that a person was selling drugs on the Reservation and was advertising
4
5 on Craigslist. I did not know what kind of drugs were involved, but decided to investigate by looking
6
7 for some key words on that site. Almost immediately, I discovered a post by Ms. Youde. A true and
8
9 correct copy of a post by Ms. Youde is attached as **Exhibit A**. I cannot represent that the post I first
10
11 saw in January is identical to Exhibit A, but I believe it was (Craigslist posts expire after about a week
12
13 and need to be renewed. Exhibit A is a post dated February 4, 2010).

16 5. I contacted Ms. Youde by email in January, but we were not able to schedule a meeting
17
18 at that time. I contacted her again on February 5th and asked if we could get something going that day.
19
20 Ms. Youde responded the next day at 12:55pm and offered to meet me between 6:30 & 7:30pm. I
21
22 suggested the "Marysville WalMart" – the name commonly used to refer to the WalMart on the west
23
24 side of I-5 at 8924 Quil Ceda Blvd., Tulalip, WA – an address on the Tulalip Reservation. At
25
26 approximately 6:00pm, she emailed me and offered to meet me at the Bank of America parking lot,
27
28 near the WalMart. The bank is also located on the west side of I-5, within the exterior boundaries of
29
30 the Tulalip Reservation and the jurisdiction of the Tulalip Police Department. A true and correct and
31
32 complete copy of our email message traffic is attached as **Exhibit B**. Afterwards, "Jen" called me at
33
34 approximately 6:30 and told me she'd be waiting at the Bank of America parking lot in a silver Honda
35
36 CRV. I agreed to meet her there.

40 6. When I arrived at the Bank of America parking lot, I approached a Honda CRV vehicle
41
42 and said, "Hello Jen." Ms. Youde was in the vehicle with a female passenger, later identified as Sherri
43
44 Danner. Ms. Youde handed me a small paper package that smelled of marijuana, and I handed her \$90
45
46 in cash. Ms. Youde did not ask me any questions or make conversation as she handed me the package.
47
48 I later determined that the packaged contained 7g of marijuana.
49
50

1 7. I walked away and other detectives moved in to contact Ms. Youde and Ms. Danner.
2
3 Ms. Danner notified another officer that there was a loaded 9mm handgun in the glove box. The
4
5 weapon was secured, both Ms. Youde and Ms. Danner were taken into custody, and the vehicle was
6
7 impounded. The \$90 I used to purchase the marijuana was recovered from Ms. Youde when she was
8
9 arrested.
10

11 8. The following items were located in the vehicle when it was searched pursuant to a
12
13 warrant authorized by Tulalip Tribal Court:
14

15 a. Over 100 grams of marijuana, packaged as follows: 4.47g in a bag marked with
16
17 the name "Daniel;" 2.14g in a bag with paraphernalia pipes; 7g in a bag marked with the name
18
19 "Andrew;" 3.5g in a bag marked with the name "Steve;" 3.5 g and 5.16g marijuana separately
20
21 packaged; 7g of marijuana separately packaged; 7g of marijuana separately packaged; 3.5g
22
23 marijuana marked with the name "Gina;" 42.5g in a jar; and 28.10g in a jar.
24
25

26 b. 49.94 grams of a solid THC substance.
27

28 c. Five Hydrocodone pills.
29

30 d. 2 bottles of hashish.
31

32 e. 3.5 and 7g of separately packaged mushrooms that appear to be psilocybin
33
34 mushrooms.
35

36 f. A digital scale.
37

38 g. Paperwork that appears to document drug delivery plans.
39

40 A true and correct copy of the Evidence Log is attached as **Exhibit C**.

42 9. Because Ms. Youde is non-Indian, I referred the charge of Possession of a Controlled
43

1 Substance to the Snohomish County Prosecuting Attorney's Office to make a charging decision. I was
2
3 subsequently notified that Ms. Youde had been charged with that offense in Snohomish County
4
5 Superior Court.
6

7 10. At the time of my initial investigation, I sent queries to at least several other Craigslist
8
9 posts that were advertising a willingness to sell marijuana in this general area. I did so by using my
10
11 true first name, Wayne," and I wrote from the email address flagrantoffender@gmail.com. Ms. Youde
12
13 is the only person who responded strongly to my inquiry. She was identified by the name "Jen," and
14
15 wrote from the email address medicalmaryj420@gmail.com.
16
17

18 11. I did not know Ms. Youde before this investigation began and met her for the first time
19
20 on February 6, 2010. I have never been a "qualifying patient" as that term is defined under
21
22 Washington's Medical Marijuana law, ch. 69.51A RCW, and I at no time gave Ms. Youde permission
23
24 to serve as a designated provider under that statute.
25


