Lynne R. Fritz, being first duly sworn upon oath, deposes and states as follows:

- 1. Affiant is currently employed in the Nebraska Attorney General's Office (NAGO) as an Assistant Attorney General and Chief of the Public Protection Bureau. She has been employed as an Assistant Attorney General in the NAGO continuously since 2001. Previously, she was employed in the NAGO as an Assistant Attorney General from 1978 to 1996. She has been employed as the Chief of the Public Protection Bureau in the NAGO from 2003 to date. All statements made by affiant hereinafter are made in her official capacity and based on her personal knowledge or information and belief regarding the provisions of Nebraska law.
- 2. Currently, and continuously since 2001, affiant's responsibilities have included enforcement of the cigarette Master Settlement Agreement (MSA) and related legislation, including Neb. Rev. Stat. §§ 69-2702 and 69-2703 (Reissue 2009) (commonly referred to as the Escrow, Qualifying or Model Statutes) and Neb. Rev. Stat.

§§ 69-2704 through 69-1710 (Reissue 2009) (commonly referred to as Complementary Legislation). In performing those responsibilities, affiant has also become familiar with the provisions of the Nebraska Cigarette Tax Act, Neb. Rev. Stat. §§ 77-2601 through 77-2622 (Reissue 2009 and Supp. 2011), Nebraska Department of Revenue (NDR) Regulations implementing said Act, including 316 NAC § 57-019, and the NDR website found at http://www.revenue.state.ne.us/cig/manufacturer.html#index containing the Nebraska Directory of Certified Tobacco Product Manufacturers and Brands (Directory) and the list of Nebraska licensed cigarette wholesale dealers.

3. Affiant is familiar with Nebraska Attorney General Opinion No. 98005 dated January 22, 1998, an accurate copy of which is attached, as Attachment 1, to the Affidavit of Joseph Messineo, dated February 28, 2012, which was previously submitted by Plaintiff in the above captioned case. Pursuant to Neb. Rev. Stat. § 84-205 (5) (Reissue 2008), the Nebraska Attorney General is required to provide his or her legal opinion in writing on questions requested by the head of any state executive department, such as the Tax Commissioner, who is the head of the NDR; however, such legal opinions are not binding in a judicial proceeding. See State ex. Rel. Spire v Beerman, 235 Neb 384, 455 NW2d 749 (1990). The description of the "Nebraska Cigarette Tax" contained in Opinion No. 98005 is unchanged to date except the amount of the tax has increased and the purposes for which the revenue is expended may have changed. (Affidavit of Messineo, Attachment 1, pp. 1 and 2, IB "Nebraska's Cigarette Tax"). The scope of Opinion No. 98005, on its face, involves only the application of the Nebraska Cigarette Tax Act to cigarettes manufactured at a facility which was owned and operated by the Omaha Tribe of Nebraska, a federally recognized Indian Tribe, and

which was also located on the Omaha reservation in Nebraska. Underlying the legal analysis of that Opinion was the fact that the cigarette manufacturing plant was a tribal enterprise. It was owned by the Tribe, established by tribal funds and revenue generated went to the Tribe. The Opinion analyzes the Tribe's legal interest in its manufacturing plant in comparison to the competing interest of the State of Nebraska in collecting cigarette tax. The Opinion provides: "...we conclude that Nebraska is preempted from imposing its cigarette tax on cigarettes manufactured and sold by the Tribe on its Reservation." (Affidavit of Messineo, Attachment 1, p. 8, IV Conclusion). The Opinion on its face does not apply to a cigarette manufacturing facility which is not owned by a Tribe nor does it apply to cigarette sales occurring off that Tribe's reservation.

4. Ohserase Manufacturing LLC (Ohserase) has submitted information about its cigarette manufacturing facility to the NDR and the NAGO in order for its cigarette products, specifically Signal brand, to be approved for sale in Nebraska. Attached hereto as Attachment 1 is a true and accurate copy of a letter dated December 6, 2010, and received by the NAGO on or about December 8, 2010, from Dale White, General Counsel for Ohserase explaining the corporate structure and identifying the four individual owners of Ohserase. Attached hereto as Attachment 2 is a true and accurate copy of the Nebraska Certificate of Tobacco Master Settlement Agreement, Form 55B, signed by Justin Tarbell as Managing Director and submitted to the NAGO and the NDR for the purpose of being included on the Directory. Attached hereto as Attachment 3 is a true and accurate copy of a letter dated December 23, 2010, and received by the NAGO on or about December 27, 2010, from Dale White, General Counsel for

Ohserase, with a multiple page document enclosed which responds to specific questions posed by the NAGO as follows: paragraph 1 identifies the four individual members with equity ownership of Ohserase; paragraph 4 states that Platinum Distribution is the sole entity designated as Ohserase's state licensed distributor in Nebraska; paragraph 10 states that Ohserase shares no profits with the St. Regis Mohawk Tribe; and paragraph 11 states that Ohserase asserts no sovereign immunity from suit in Nebraska. Attached hereto as Attachment 4 is a Consent to Suit signed by Justin Tarbell on behalf of Ohserase and a "Action by Unanimous Written Consent of the members of Ohserase Manufacturing, LLC" authorized Justin Tarbell to act on behalf of Ohserase.

- 5. Pursuant to Neb. Rev. Stat. § 77-2615 (Reissue 2009), it is illegal to sell, deliver or accept cigarettes upon which the Nebraska cigarette tax has not been paid with the intent to evade the provisions of the Nebraska Cigarette Tax Act. Where a person is found to possess more than 10 packages of unstamped cigarettes, unless the person is a Nebraska licensed wholesale dealer, it is prima facie evidence of an attempt to evade the provisions of said Act.
- 6. Pursuant to Neb. Rev. Stat. § 77-2620 (Reissue 2009) all cigarettes subject to the Nebraska Cigarette Tax Act, which are unstamped (except those in the possession of a Nebraska licensed wholesale dealer and intended for sale in another state within 30 days, under Neb. Rev. Stat. § 77-2607) and which are found in Nebraska, are contraband and subject to seizure by law enforcement or agents of the Tax Commissioner.

- 7. Pursuant to NDR regulations, Title 316 § 57.019, a true and accurate copy of which is attached hereto as Attachment 5 and which can also found at http://www.sos.ne.gov/rules-and-regs/regsearch/Rules/Revenue_Dept_of/Title-316/
 Chapter-57.pdf, an exemption to payment of the cigarette tax is created for Native American consumers purchasing cigarettes within the Native American reservation. The retailer located on the reservation making the exempt sale to a Native American may receive a credit for the cigarette tax by providing information to the Nebraska licensed cigarette wholesale dealer on a Form 68 distinguishing the exempt sale to a Native American from other nonexempt sales. The Nebraska licensed wholesale dealer may then receive a credit for the cigarette tax paid by submitting the Form 68 to the NDR.
- 8. HCI Distribution Inc. (HCI) is a division of Ho-Chunk Inc. which is owned by the Winnebago Tribe of Nebraska. HCI is not a Nebraska licensed cigarette wholesale dealer. It is not on the list of Nebraska licensed cigarette wholesale dealers maintained by the NDR at the internet address set forth in paragraph 2 above. No other business entity owned by the Winnebago Tribe is a Nebraska licensed cigarette wholesale dealer.
- 9. Attached hereto as Attachment 6 is an accurate copy of two pages printed from the internet on March 7, 2012 at www.allnativesmokeshop.com. The website states that All Native Smokeshop is a Division of Ho-Chunk, Inc., owned by the Winnebago Tribe of Nebraska; its Smokeshop is located in Ho-Chunk Village on the north edge of Winnebago, Nebraska. A map is provided showing driving routes from

multiple Nebraska locations, including Lincoln, NE and Omaha, NE. One of the cigarette brands listed on the website as a "Best Seller" is Signal brand cigarettes.

- 10. Pursuant to Neb. Rev. Stat. § 77-2621 (Reissue 2009), a common carrier may obtain a permit from the NDR to carry unstamped cigarettes from a bonded warehouse to a licensed cigarette wholesale dealer. D and T Transport, Inc. does not have such a permit.
- 11. If the cigarette shipment described in the Verified Petition filed in the above captioned case would have proceeded into Nebraska, in affiant's legal opinion, it would have been contraband and subject to seizure, outside the boundaries of the Winnebago reservation, under the provisions of the Nebraska Cigarette Tax Act.

The purpose of this letter is to notify you of a change in the corporate structure of our company and to seek a determination on its affect on our recently approval by your office of our company and its brand, Signal Cigarettes, to the Nevada Directory of Certified Tobacco Product Manufacturers and Brands. On November 24, 2010, in response to our application, the U.S. Department of Treasury, Alcohol and Tobacco Tax and Trade Bureau (TTB) issued a new TTB Permit (TP-NY-15042) to us, based upon a change in our corporate structure—we have formed a Limited Liability Company under the St Regis Mohawk Tribal LLC Code. Our new permit will be for "Ohserase Manufacturing, LLC" instead of "Justin Tarbell dba Ohserase Manufacturing". A copy of the new TTB permit is also attached hereto. Please note that this is not a change in our tobacco product, Signal Cigarettes. We will continue to manufacture exactly the same product as was manufactured under our old permit.

Briefly, here are the only changes in our company due to the restructuring:

- (1) Our name will change from "Justin Tarbell dba Ohserase Manufacturing" to "Ohserase Manufacturing, LLC".
- (2) We are now a Limited Liability Company formed under laws of the St. Regis Mohawk Tribe instead of a sole proprietorship.
- (3) The LLC has four (4) owners (members): Justin Tarbell, Eli Tarbell, Christy Laguador and Ryanne Araujo.
- (4) There is a name change in our address—from "Hogansburg" NY to "Akwesasne", but that is a change in name only—the plant is still at the same physical address.

Obviously, we would prefer that your office treat this as a request to "Supplement" or "Amend" our current Certificate. The changes to our company are limited to the three changes mentioned above. Our tobacco product remains the same. Most, if not all of the information submitted in our application for Justin Tarbell dba Ohserase Manufacturing is applicable to the LLC that has been established. Obviously, we can, and will provide all the information you need if you have questions about the additional members of the company. If, however, you decide to treat this as 355 trogtown Road an entirely new application, we would request that you use the information that we have

REG-57-019 EXEMPTION FOR NATIVE AMERICAN INDIANS

019.01 Any sale of cigarettes to a Native American Indian where title and possession are taken within the boundaries of an Indian Reservation in Nebraska is exempt from tax.

019.02 Retailers making exempt cigarette sales may receive a credit for the cigarette tax. To support the credit the retailer must distinguish on his or her cigarette sales records the exempt sales to Native American Indians from the nonexempt sales.

019.03 A claim for credit of cigarette tax must be made to the licensed wholesale distributor on the Nebraska Credit Computation for Cigarettes and Tobacco Products Sold to Native American Reservation Indians, Form 68.

019.04 Licensed wholesale distributors receive credit for the cigarette tax paid by submitting the completed Form 68 with a subsequent Nebraska Cigarette Purchase Order for Stamps and Impressions.


