## Judge rules Comanches remain out

A court order recognizing a half-dozen Comanches as tribal officials was dismissed Friday during a hearing in Anadarko.

Judge Phil Lujan of the Bureau of Indian Affairs Court of Indian Offenses CFR Court ruled to dismiss his previous court order recognizing five — Ed Eschiti, Robert Tippeconnie, Ron Red Elk, Darrell Koseche-

quetah, and Yonavea Terry, as the Comanche Business Committee (CBC) as well as for Robert Komahcheet as the tribal administrator. He cited a lack of jurisdic-

tion for the dismissal.

"With his ruling today, Judge Lujan has given the Comanche Nation the help we need to move forward in our fight for tribal sovereignty." said Chairman

Wallace Coffey. "It is a major victory for the Comanche Nation people and all Native American Tribes across the Nation.

Lujan reversed his June 6 ruling over the issue. He cited an impending shutdown of tribe businesses, services and programs due to the freeze of Comanche bank accounts at International Bank of Commerce as the reason the CBC would be recognized. Lujan stated he issued the emergency interim order to alleviate unnecessary suffering and economic distress of the Comanche Nation.

sent the tribe. The quorum gathered at the May 19 meeting approved their representation of the six former CBC members.

A freeze to the tribe's bank accounts with International Bank of Commerce remains in effect. The Texas-based bank filed a complaint June 1 in Western District U.S. Federal Court due to the leadership uncertainty. The bank claims it froze the tribe's seven individual accounts on May 29 due to competing claims of signatory authority. Records show the two fac-

tions are "making claims" to the \$6.5 million in the account. It is expected that, with the installation of a new quorum of business officers, no question will remain as to who has authority.

There is a mandatory three-day protest period, and the results will become official 5 p.m. July 3, if no protests are filed.
