BACKGROUND AND PURPOSE

In this program, state and tribal court experts will team up to guide participants through an introduction and overview of the recently enacted Michigan Indian Family Preservation Act (MIFPA). This training opportunity will provide information on the historical background of the new law, clarification of certain federal Indian Child Welfare Act (ICWA) provisions and definitions, and how child welfare professionals can comply with the MIFPA. Chief Tribal Court Judge Allie Maldonado will provide historical context for the new legislation by guiding participants through historical treatment of Native American families in the United States and in Michigan. She will describe the purpose and intent of the ICWA and MIFPA. Washtenaw Circuit Court Judge Timothy Connors will discuss the legislation as one of many ongoing efforts to promote healthy relationships between state and tribal courts in Michigan and among our sister states. Annette Nickel, prosecuting attorney for the Pokagon Band of Potawatomi Indians, will facilitate interactive case study exercises to put the "Act" into action. Audience members will have an opportunity to engage in a constructive dialogue about the policy and practice implications of the groundbreaking new law. This is a full day highlighting the cultural context, collaboration, and compliance when working with Native American families in the child welfare system.
