You are hereby notified that the misappropriation of funds matter has been heard ex parte before the Honorable Moapa Tribal Court this 20th day of November 2012. In the forgoing matter, this court has both personal, civil and subject matter jurisdiction over how WELLS FARGO FINANCIAL ADVISORS, Jason Allen and Mike Kratzyke, have handled the tribe's investment accounts. To date, the tribe records show a loss of over 3 million dollars in value of their accounts and a long history of unauthorized transactions that appear to be churning of their stock portfolio.

Pursuant to this ex parte complaint, the Defendants are hereby notified that a claim of more than \$3,800,000.00 has been levied against you for mismanagement, misappropriation, and unauthorized taking of the Moapa Band of Paiutes funds as late

5 order whereby you are directed by this Court to cease and desist
6 any transfer, spending, trading, transacting or otherwise using
7 the Moapa Band of Paiutes funds from account 6700-0679 and any
8 and all other accounts until a formal hearing on the matter is
9 heard. The Court will hold a hearing upon this claim on December
10 7 at 10:00 AM.

12 You are required to be present at the hearing in order to avoid
13 a judgment by default. If you have witnesses, books, receipts,
14 or other writings bearing on this claim, you should bring them
15 with you at the time of the hearing.

17 If you wish to have witnesses summoned, see the Clerk at once

20 If you admit the claim, but desire additional time for you to
21 pay, you must come to the hearing in person and state the
22 circumstances to the Court. You may bring an attorney who is
