MOTION WRIT OF FEDERAL PROTECTION (Temporary Restraining Order)

COMES NOW, the Plaintiff, requesting this court to immediately issue a Writ of Federal Protection, or Temporary Restraining Order, to the Defendants in this case, for the length of this case.

Judge Terry Wooten denied Plaintiffs Motion for Writ of Federal Protection on October 28, 2013 for lack of just case. Coincidentally, after the denial of Federal Protection, the Plaintiffs and their reservation, was raided on December 11, 2013. Plaintiffs were held at gunpoint by approximately 40 armed SLED, and Allendale County Sheriff Deputies, while their homes were being searched, and tribal members being harassed and antagonized.

Chief Brenda Red Crow Webb, and Chief Justice CJ Webb, was taken into custody on false accusations and charges. Neither was read Miranda rights, given the opportunity to call their attorney, or make their first phone call. Chief Justice CJ Webb was arrested without a warrant. Warrant was not issued until 36 hours after Chief Justice was arrested and confined.

There were also racial slurs thrown at Chief Brenda Red Crow Webb, and clear hatred stated and shown to Plaintiffs during the raid. Plaintiffs is informed and believes that because the skin tone of the members of the Plaintiffs (Yamassee Indian Tribe) is darker and more "negroid" that the officials of the County of Allendale and SLED, based solely

upon the racial features of the Plaintiffs, have concluded that the laws of the State of South Carolina, and the Federal Laws of the United States, do not apply to Plaintiffs and should be, and are being ignored. Plaintiffs believe that this was done in retaliation of this lawsuit, and Defendants monitoring of this case.

Plaintiffs are continuously being intimidated by the constant drive bys of Sheriff Deputies, and also by the Stalking of Deputies and other governmental officials of Plaintiffs daily, thenceforth, during Plaintiffs day-to-day travel and living activities. Plaintiffs are now therefore, in fear of their lives.

Plaintiffs is requesting that the Writ of Federal Protection be scheduling and issued immediately so as not to cause Plaintiffs any more undue hardship or harm.
