Plaintiffs request judgment on costs pursuant to LCR 54(d), 28 U.S.C. § 1920, and Federal Rule of Civil Procedure 54.

In their response (Dkt. # 222), Defendants conceded that Plaintiffs are entitled to costs and dispute—solely—the amount of costs to which Plaintiffs are entitled. Plaintiffs expedited most transcripts (as Defendants were aware, since all ordering was done in the presence of all counsel of record). Expedited transcripts cost more than the transcripts Defendants ordered. *See* Declaration of Molly Jones. But expedited transcripts were necessary in every instance for transcripts to be produced in time for use in relevant motions and court proceedings. All invoices for transcripts are attached to the Declaration of Molly Jones.
