Holistic Approach to Civil and Criminal Legal Assistance in Tribal Justice Systems

This training, which NAICJA developed with a BJA grant, will highlight successful models that illustrate that various components of a justice system (e.g., codes, court rules, court procedures, legal assistance, corrections, probation, etc.) must be considered as a whole rather than as stand-alone services. The goal of this training is to bring together teams of tribal justice stakeholders from various communities in order to examine and strategize on how criminal and civil legal assistance and access to these services can be provided and improved through a collaborative, holistic approach. The training will also highlight the Tulalip Tribe's justice system and the Salish and Kootenai's Office of Public Defense, and key players from various components of the justice system will serve as panelists. Each jurisdictional team will ideally consist of a tribal judge, prosecutor, tribal attorney general, public defender/legal aid advocate, probation officer, and/or a tribal leader working with the same tribe. Individuals without a jurisdictional team are also encouraged to attend.

The training is free, but invitees must cover the cost of their travel, food, and lodging. **Please contact Nikki Borchardt Campbell if you would like to register, nikki@naicja.org. This session provides an overview of the TLOA of 2010. The enhanced sentencing of TLOA will be discussed along with the requirements for eligibility, when the enhanced sentencing can be utilized, and the standards that tribes must meet in order to exercise this enhanced sentencing. Meeting these standards involve far more than just providing legal representation to defendants, instead implementation often requires a system-wide response and effort.

10:00 AM Importance of Collaboration and Communication in Tribal Justice Systems.

The key to providing a successful all-around services to indigent defendants and those seeking civil assistance is intra-tribal communication and collaboration. The panelists introduce their models of and describe the level of communication that takes place within tribal justice systems to ensure successful practices.

11:00 AM Roundtables 1 | Communication within Justice Systems and Tribes: Working Together

During this first roundtable session, the teams and individuals will work in groups defined by community. They will meet and work together to identify how they currently share information and communicate about the services they provide, identify the needs of their clientele and the resources available to them. They will then identify ways to improve or establish the communication processes and protocols between their respective departments or organizations. This will entail coming to a consensus on types of information they should and could share, identifying obstacles to sharing and communicating, and devising a strategy to overcome any identified obstacles.

1:30 PM Criminal Indigent Defense in Indian Country - Holistic Defense Models

This session explores the holistic defense model and its application in the tribal setting. Holistic defense is an innovative, client-centered approach to public defense representation that addresses both the *circumstances* driving people into the criminal justice system as well as the *consequences* of that involvement by offering criminal, and related civil legal representation, social work support, and advocacy in the community. The benefits of this model will be explained, as well as, how this model of tribal defense comports with many traditional, tribal notions of justice.

For those attending as individuals, they will be asked to also develop an action plan and timeline based on the brainstorming sessions.
