- 2. I am the Tribe's elected Tribal Council Secretary, and a member of the Board of Directors for the Rolling Hills Health Clinic and Dental Lab.
- 3. I am over eighteen years of age, I am competent to testify, and I have personal knowledge of the facts set forth herein.
- 4. With respect, I offer this Declaration without waiving my sovereign immunity protection as a Tribal member and without consenting myself or the Tribe or any Tribal entity to the jurisdiction of the Court. Neither I, nor the Tribe, nor any Tribal entity consents to discovery, suit, examination, or any other court or administrative process. I offer this declaration for the benefit of the Court only.
- 5. Chairman Freeman and Defendants have advised Rolling Hills Casino employees to cash their paychecks at the casino cage.
- 6. Chairman Freeman has directed Rolling Hills Casino agents to transport large amounts of cash out the casino and into a white Sport Utility Vehicle each morning to an unknown and undisclosed location.
- 7. On April 28, 2014, several armed guards approached a group of non-Indian golfers conversing in the parking lot of the Servillano Links and directed those patrons of Paskenta to vacate the premises immediately.

governmental activities;

WHEREAS: The Tribal Council believes that it is important for the Tribe to conduct

business in a regular manner.

NOW, THEREFORE, BE IT RESOLVED that the Tribal Council hereby ratifies, approves, and confirms David Swearinger, Vice-Chairman; Geraldine Freeman, Secretary; Leslie Lohse, Treasurer; and Allen Swearinger, Members-at-Large, as signatories to the Tribe's and all Tribal Enterprises bank accounts.

BE IT FURTHER RESOLVED that the Tribal Council hereby requests the financial institutions at which the Triba and Tribal Enterprises maintain deposit and other related accounts recognize that a majority of the Tribal Council supports continued, uninterrupted and unrestricted access by the Triba to Tribal and federal funds on deposit with said financial institutions.

BE IT FURTHER RESOLVED that the Tribal Council requests that the financial institutions disregard requests from others and recognize the elected Tribal Council described herein and recognized by the U.S. Department of the Interior, Bureau of Indian Affairs.

BE IT FURTHER RESOLVED that the Tribal Council hereby disclaims and disavows any action purported to be taken in the name of the Tribe but not made in accordance with the provisions of this Resolution.

WHEREAS: The Tribal Council believes that it is important for the Tribe to conduct business in a regular manner without the potential for unauthorized persons to access the Line of Credit and other bank accounts.

NOW, THEREFORE, BE IT RESOLVED that the Tribal Council hereby ratifies, approves, and confirms David Swearinger, Vice-Chairman; Geraldine Freeman, Secretary; Leslie Lohse, Treasurer; and Allen Swearinger, Member-at-Large, as the only signatories to the Tribe's and all Tribal Enterprises' bank accounts, lines of credit, or other financial arrangements or relationships, and hereby revokes any signatory authority previously held by Andrew Freeman, Ambrosia Rico, Andrew Alejandre, Latisha Miller, Jeff Realander, Bruce Thomas, Chuck Galford, and Terry Contreras, or anyone acting on their behalf.

BE IT FURTHER RESOLVED that the Tribal Council hereby demands and instructs that Wells Fargo Bank, NA and its affiliates do not allow, authorize or otherwise permit any draws or funding with respect to the Wells Fargo Line of Credit unless authorized in writing by at least a super-majority of four of the five Tribal Council members.

BE IT FURTHER RESOLVED that the Tribal Council hereby instructs Wells Fargo to ignore any instructions previously or in future received from any other party concerning the Line of Credit, including, without limitation, any instruction from Andrew Freeman, Ambrosia Rico, Andrew Alejandre, Latisha Miller, Jeff Realander, Bruce Thomas, Chuck Galford, and Terry Contreras, or anyone acting on their behalf, and hereby resolves that any signatory authority possessed by any of the foregoing is hereby revoked, rescinded and is deemed void *ab initio* by the Tribal Council.

BE IT FURTHER RESOLVED that the Tribal Council demands and instructs that all financial institutions, including without limitation Wells Fargo Bank, NA and Cornerstone Community Bank, disregard any requests or instructions from any other persons and recognize only the contracting power and authority of the elected Tribal Council described herein and recognized by the U.S. Department of the Interior, Bureau of Indian Affairs, acting by action of the four Tribal Council members enacting this resolution.

BE IT FURTHER RESOLVED that the Tribal Council hereby disclaims and disavows any action previously or in future purported to be taken in the name of the Tribe but not made in accordance with the provisions of this Resolution.

NOW, THEREFORE, BE IT RESOLVED that, to the extent any employment relationship exists or existed between the Tribe and the people listed on Appendix A, it is terminated; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Tribal Police Department shall immediately serve the attached Notice upon the people listed on Appendix A, and remove and exclude them from the Rolling Hills Casino and all other Tribal properties, and all lands described in Article I of the Tribal Constitution. Should any such person resist their removal and exclusion, Tribal Police Officers are hereby authorized to civilly detain, remove and exclude such person and/or cite them into Tribal Court for applicable violations of Tribal law, including disorderly conduct or trespass (or into the Tribal Council, if the Tribal Court is not yet established). Said citation of such person may include civil fines of up to \$10,000 per trespass or disorderly conduct offense. Any such person who is detained, removed, excluded or cited shall be afforded the rights secured by Article X of the Tribe's Constitution; and

NOW, THEREFORE, BE IT FURTHER RESOLVED that, to the extent any Tribal Gaming Commissioner appointment or employment relationship exists or existed between the Triba and any "John Doe" or "Jane Doe" Gaming Commissioners, who are unbeknownst to the Tribal Council, any such appointment or employment is terminated.

At aprox 0225 hrs on April 20th, 2014 I received a phone call from Officer Krista Rife (P-13) who was working at 1012 South Street in Orland, CA. Officer Rife informed me that just prior to calling me, a group of subjects had arrived at the location and gathered around the front door of the tribal office. Officer Rife stated that she had spoken with a male by the name of Art who appeared to be affiliated with Rolling Hills Casino security or staff. Officer Rife stated that Art informed her that they intended to change the lock on the door of the tribal office. At aprox 0254 hrs I arrived at 1012 South Street an excited my patrol vehicle. I was met by Officer Rife and Officer Ruben Horton (P-36), I could hear an audible alarm going off. I asked Officer Rife if the subjects at the front door of the building had an alarm code, Officer Rife responded that they did not. Officer Horton stated that the subjects attempting to gain entry into the tribal office told him that they had informed Orland PD of their intentions to change the locks. Officer Rife stated that the subjects attempting to gain entry arrived in aprox 5 different vehicles. I then looked over at the front of the tribal office building. I could see several subjects standing in front of the door, with one subject kneeling near the door; I could hear the sound of a drill grinding on metal. At aprox 0255 hrs I called the Orland Police Department, and informed the dispatcher who I was and that I needed an officer to respond because the subjects attempting to gain access to the building did not have a key.

Two Orland PD officers arrived onsite, at this point the subjects had made entry into the building and the alarm was still sounding. The Orland PD officers began to speak with the subjects near the tribal building. Officer Rife pointed out Art to me and I asked him if I could speak to him. Art began to speak to me in front of the tribal building but walked over to the left side of the door. I noticed there were 4 male subjects all wearing black uniforms resembling police style uniforms, however I did not see any arm patches, badges or any wording on the clothing. All 4 of the male subjects were wearing police style duty belts and all of them were carrying exposed firearms and batons. I asked Art what was going on, he stated that they were changing the locks on the building under the belief that it was theirs. He stated that "possession is 9 points of the law, and we have the 9 points." I informed Art that I had documentation from the Federal Government that stated that our clients were the last tribal council on record. Art stated that the paper I had was old and that the Bureau of Indian Affairs "is just a record keeper." He continued to state that the side of the tribe he was with had held a vote recently and had already elected the

tribal council, and that information had been sent to the Federal Government. I told Art that the document I had reviewed had a date of 2011 on it and that if the people on it were no longer council members than his people must have recently voted to change that. He agreed but would not give me an exact date as to when a vote had been held or when they had submitted their new council information to the Federal Government.

I then focused my attention on the 4 male subjects wearing the police style uniforms that were standing next to me while I was talking to Art. I asked the subjects what security company they were from. One of the subject stated they were from Zaks Security out of Madera, CA. Seeing as they identified themselves as security I found it odd that none of them were wearing arm patches or any insignia that identified them as security and what company they work for, a violation of Business and Profession Code section 7582.27(a). I asked the subjects what their Private Patrol Operator number was; they verbally refused to tell me the number. I asked them if they were carrying weapons to which that all stated that they were. I then informed all of them that they were not in compliance with section 7582.27(a) and that I could file a complaint with the Bureau of Security and Investigative Services, they stated that was fine, but until then they were not going to tell me any more information. I again stated that they were violating section 7582.27(a). to which one of the subjects stated that "it was more of a regulation than a law." The same subject then asked me if I was aware that "tribal land is federal." I told the subject that it might be that case, but security is regulated by the State of California and a security contract and security guards are regulated by California State law. I then asked all of them if they had guard cards or exposed weapon permits, to which they paused and stated that they would only answer those questions from law enforcement. I asked them if they would give me the street address to Zaks security, but they did not, however Art who was still standing next to me gave the address of 2655 Everett Freeman Way, which sounded like the tribal office that his people were operating out of, but I was not able to confirm the exact purpose of the address he gave me.

I then walked over to Orland Police Officer Bryan Simpson (Badge # 508) I informed him of the situation with the 4 unmarked security guards and explained my concerns based on the laws that my company follows and his right as a police officer to check and see if the 4 subjects even had state licenses to carry exposed weapons and batons. He stated that his role was to keep the peace and that he was not going to check their permits, however he did mention that I should speak to the Sergeant about it. I then spoke with my officers about the situation and briefed them on the 4 security guards and their lack of any identification.

I then spoke with Sergeant Joe Vlach (Badge # 502) of Orland PD, in which I again voiced my concerns about the 4 armed subjects that were supposedly security guards. He stated that he was not going to check their permits but that he would talk to Art about having them send over the security company's information so the Chief of Police could review it. I then asked him if he would like to see my officer's permits but he declined. He went on to say that he believed this situation regarding the dispute between the tribe is something that will need to be handled in a court setting. I told Sgt. Vlach that my clients hold a document from the Federal Government stated that they are the last tribal council of record. He asked me what the year on it was, I stated that it was dated 2011. He replied that Orland PD had a copy of the same 2011 document that my clients had. I thanked the Sergeant for his time and he and Officer Simpson departed the area. Art and the other subjects with him had finished changing the locks on the door and had scraped off the entire printed wording on the windows; they then left the area as well. Two of the armed security guards hired by Art and his group, stayed on site in a black Chevy Silverado pickup truck CA 7V65288. I then asked Officer Rife if she had seen any of the subjects remove any computers from the office. She said that she saw no computers being moved, but the group did take some papers. I then briefed Officer Rife and Office Horton on where I wanted them to be in relation to the other armed subjects in the black Chevy pickup truck, due to their confrontational nature and the fact that I had no factual information if they are even licensed security guards. I then departed the area.

I Bailey Phillip Swearinger was present for the Annual General Council meeting for the Paskenta Band of Nomlaki Indians on Saturday April 12, 2014. I was sitting in approximately the fourth row back from the front on the left side of the room. I was to the left of where the Tribal Council was seated for the meeting.

The meeting was started off by Cody Pata giving a prayer in our Nomlaki language to begin the meeting. Next the roll was taken which took approximately 15 minutes. Security began coming into Carlinos right after Geri's blessing. I noticed there were security employees coming into Carlinos that weren't working their normal shifts. Andy began reading a prepared statement announcing that the Henthorne, Pata, Crosby and Lohse families weren't legally on the Paskenta roll and that Ines Crosby has known it from the beginning, and that the Freeman family had proof that they weren't even Nomlaki's. Immediately along with regular security officers came many sheriffs officers and highway patrol officers also. Rolling Hills Security officers surrounded the back of the Tribal Council. I could see they were being surrounded by the crowd and it didn't look safe up there for anyone.

The (first three rows) stood up and began yelling and became unruly. The cops tried to calm them down and then tried talking to John Crosby and then I heard David Swearinger made a motion to adjourn the meeting and Geri Freeman seconded it and then I heard David adjourn the meeting. Then I heard Kim, Tracy and Brenda yelling you can't adjourn the meeting, that's when the police tried to calm them down. Corning P/D tried to settle them down and walked up to Kim Tracy and Brenda and Brenda yelled I'm tribal and you cant touch me. It was at that time, my mom Debbie sent me outside to look for my dad. Shortly after she came out and said the crowd got much worse and she feared for her safety and left.

PASKENTA BAND OF NOMLAKI INDIANS TALKING POINTS

The Paskenta Band of Nomlaki Indians, a federally recognized Indian Tribe that operates the Rolling Hills Casino, is in the process of determining whether the Henthorne-Pata families, which includes Leslie Lohse, meet the Membership criteria set forth in the Tribe's Constitution.

- At a duly noticed, called and held Annual General Council Meeting on April 12, 2014 wherein a
 Quorum of the General Council was present, the Constitutional Membership issue was raised, and
 certain Tribal Council Members, including Leslie Lohse, knowingly vacated their seats on the
 Tribal Council. These Members were provided with notice to contest that they were vacating their
 seats and thus creating vacancies which were filled according to Tribal law.
- At the same meeting, the General Council heard from Dr. Dorothy Theodoratus, the expert who
 had conducted the original anthropologic and genealogy investigations and documentation for the
 Tribe's restoration, who stated that no evidence exists that the Henthorne-Pata families meet the
 Tribe's minimum threshold Constitutional criteria for Membership.
- The General Council then promptly suspended the Henthorne-Pata families from Tribal privileges and benefits until due process and an opportunity to be heard could be scheduled.
- On April 21, 2014, the Tribe received an e-mail from NCAI Executive Director, Jackie Johnson-Pata, whose husband belongs to the Henthorne-Pata family, which included a letter from the BIA and the NIGC, expressing concern regarding the General Council's governmental decision to suspend the Henthorne-Pata families.
- The Tribe, through its Chairman, Andrew Freeman, immediately met with Troy Burdick, Superintendent of the BIA to understand the BIA's concerns. The BIA questioned whether the General Council intended its actions, and also suggested federal mediation of the Membership issue. Chairman Freeman agreed to have a second General Council Meeting to affirm the actions taken, and also agreed to allow a federal mediator to decide or review the Membership issues.
- The Chairman also met with the Regional Office of the NIGC, Eric Shalansky. Chairman Freeman similarly demonstrated to the NIGC that a second General Council Meeting was being scheduled to affirm previous actions, and explained the Tribe is amenable to a federal mediation process on the Membership issues. Chairman Freeman also welcomed any NIGC investigations.
- The Chairman also discussed NCAI Executive Director Jackie Johnson-Pata's correspondence
 with President Cladoosby of the NCAI. President Cladoosby apologized for Ms. Johnson-Pata's
 correspondence explaining that she acted outside of her official capacity and not within her scope
 of duties.
- Chairman Freeman, true to his word, has scheduled a General Council Meeting for Saturday, May 10, 2014, to conduct the following Tribal Business:
 - o Reaffirm the actions taken by the General Council at its April 12, 2014 Meeting;
 - Enact an initiative allowing for the Henthorne-Pata families to receive due process and an opportunity for a Hearing regarding their Membership issues; and
 - Authorize a federal mediator to either make a decision regarding the Membership issues or allow for a review of the Tribal process regarding the Membership issues.

- Chairman Freeman has invited the BIA and the NIGC to witness the General Council Meeting.
- Members of the Henthorne-Pata families that have suspended include John Crosby, former Economic Development Director, Ines Crosby, former Tribal Administrator, John and Ted Pata, former Gaming Commissioners and Leslie Lohse, former Tribal Treasurer.
- The recent changes in Tribal Administration have allowed the Tribe to engage a nationally known forensic accounting firm for the review of Tribal banking and other records, which has revealed evidence of serious misappropriation of Tribal funds.
- Meetings are ongoing with the Tehama County Sherriff's Department, Tehama County District Attorney, and Corning Police Department. The Tribal Council intends to formally refer this investigation to the Tehama County Sheriff's Office and the United States Department of Justice for prosecution.

Dear Mr. Swearinger:

The Tribal Council is in receipt of the letter you sent to the General Council on April 30, 2014 and the letters you have sent to Chairman Andrew Freeman dated April 25, May 4 and May 5, 2014. The purpose of this letter is to demand that you immediately *cease and desist* from sending any further correspondence to the General Council, the Chairman, the Tribal Council, or any State or federal agency under the cover or identity as a Tribal Council Member. As you know, Article VIII of the Tribe's Constitution requires your attendance at General Council Meetings, and if you are not in attendance it "shall be grounds for immediate removal." Notably, the Chairman warned you at the April 12, 2014 General Council Meeting that if you left the General Council Meeting you would be abandoning your post on the Tribal Council. Despite the clear warning, you left the General Council Meeting and the General Council acted entirely within their constitutional authority by immediately and unanimously removing you from office.

Please be advised that your unwillingness to immediately adhere to this cease and desist order may trigger grounds for suspension of your Tribal Membership privileges pursuant to the Tribe's Membership Act, Article III, Section 3-302, "(h) Disruption of the Tribal government or a Tribal business; (j) Submitting a statement or other information to an Official or Agency of the Tribe, or to an entity of another government, that the Member knew or should have known to be false, fictitious or fraudulent in any material respect; or (k) Any other act that harms, jeopardizes or brings disrepute onto the Tribe, a Tribal Member or a Tribal business or enterprise." Furthermore, if you continue to disrupt the government operations of the Paskenta Tribe of Nomlaki Indians by misrepresenting your status as a Tribal Council Member, it could be grounds for termination of your Tribal Membership privileges pursuant to the Tribe's Membership Act, Article IV, Section 3-402 "(a) Any act or pattern of conduct that would constitute grounds for suspension and temporary disenrollment from the Tribe under Section 3-302; (d) Interference with the Tribe's business relationships and undertakings; and (e) Conduct significantly detrimental to the Tribe, its Members or it businesses or undertakings."

Finally, as you know, the Chairman and Tribal Council have voluntarily called for a General Council Meeting to occur this Saturday, May 10, 2014. This General Council Meeting was called as a direct and proximate result of your gross mischaracterization of the facts as they occurred on April 12, 2014, made to the BIA, NIGC, Congressman LaMalfa, and a myriad of other state and federal agencies, and so we believe it's in the best interest of the Tribe to have a second meeting to reaffirm all prior actions of the General Council. We have encouraged representatives from the BIA, NIGC and Congressman LaMalfa's office to be present, and we would encourage you to be present as well and to make any objections you have known directly to the General Council.



WHEREAS: The Paskenta Band of Nomlaki Indians (the "Tribe") is a federally recognized Indian tribe; and

WHEREAS: The Tribe is governed by a Constitution (the "Tribal Constitution") approved by the members of the Tribe on April 18, 1998, approved by the Secretary of the Interior on May 15, 1998, and amended by the members of the Tribe on April 17, 2004; and

WHEREAS: Article III, Section 1 of the Tribal Constitution provides that the governing body of the Triba is the Tribal Council; and

WHEREAS: Article V, Section 1 of the Tribal Constitution provides that if a member of the Tribal Council is absent from three consecutive regular meetings in any twelve month period, the Tribal Council shall declare the position vacant; and

WHEREAS: The Tribal Council adopted Resolution No. 2014-0421, pursuant to Article VII, Section 1(a) of the Tribal Constitution, the Tribal Council designated a schedule of Tribal Council regular meetings for: Tuesday, April 29, 2014 at 6:00 PM, Wednesday, April 30, 2014 at 6:00 PM, and Friday, May 1, 2014 at 1:00 PM; and because "[c]urrent Tribal Council Members have been purportedly 'banned' from access to Tribal trust land and properties" and "is committed to avoiding conflict or violence and instead to keeping the peace throughout Paskenta Indian country," the three regular meetings were designated to occur at the Orland Public Library; and

WHEREAS: The Tribal Council ensured that Resolution No. 2014-0421 was provided to all five members of the Tribal Council; and

WHEREAS: A quorum of the Tribal Council convened the three regular meetings at the dates, time and location designated by Resolution No. 2014-0421, but Chairperson Andrew Freeman failed to attend those three consecutive regular meetings; and

WHEREAS: The Tribal Council determined that it is in the best interests of the Tribe to declare the position of the Tribal Chairperson vacant; and WHEREAS: On April 24, 2014, Andrew Freeman noticed a General Council special meeting to occur on May 10, 2014 at 10:00 a.m., at Carlino's Event Center at Rolling Hills Casino; and

WHEREAS: Article VII, Section 2(b) of the Tribal Constitution allows the Tribal Council to cancel special meetings of the General Council called by the Tribal Council Chairperson even after a ten-day notice is given; and

WHEREAS: Recent events at Paskenta, most notably what transpired at the General Council Annual Meeting before the meeting was adjourned by the Tribal Council on April 12, 2014, have placed the health, welfare, security, and safety of the Tribe and the entire Paskenta membership in serious peril; and

WHEREAS: The Tribal Council determined that it is in the best interests of the Tribe to cancel the special meeting scheduled to occur at Carlino's Event Center at Rolling Hills Casino on Saturday, May 10, 2014, at 10:00 a.m.; and

NOW, THEREFORE, BE IT RESOLVED that pursuant to Article V, Section 1 of the Tribal Constitution, the Tribal Council hereby declares the position of the Tribal Chairperson VACANT, effective immediately.

NOW, THEREFORE, BE IT FURTHER RESOLVED that a special election to fill the vacant position of the Tribal Chairperson shall be held in thirty (30) days in accordance with Article V, Section 1 of the Tribal Constitution and the Tribe's Election Ordinance. During those thirty (30) days, the Tribal Council Vice-Chairperson shall preside over any meetings of the Tribal Council and/or the General Council, and in that capacity shall be entitled to exercise all of the powers and be obligated to discharge all of the responsibilities of the Tribal Chairperson

NOW, THEREFORE, BE IT FURTHER RESOLVED that effective immediately any act made by Andrew Freeman as purported Chairperson of the Paskenta Band of Nomlaki Indians shall be legally *ultra vires*, void *ab initio*, and of no legal effect, including any act to convene, preside over or otherwise carry out the May 10, 2014 General Council special meeting.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the General Council special meeting scheduled to occur at Carlino's Event Center at Rolling Hills Casino on Saturday, May 10, 2014, at 10:00 a.m., is hereby **CANCELLED**.

Dear Mr. Swearinger, Mrs. Freeman, Mrs. Lohse, and Mr. Swearinger:

This is to address your letter dated May 1, 2014, where you request this Office write an advisory letter acknowledging the last undisputed elected leadership of the Paskenta Tribe of Nomlaki Indians as the rightful leadership of the Tribe.

The Pacific Regional Office is aware of the dispute within the Paskenta Band of Nomlaki Indians (Tribe), where in two factions have emerged. One faction is lead by Chairman Andrew Freeman and the other faction is lead by the four members of the Tribal Council, David Swearinger, Geraldine Freeman, Leslie Lohse, and Allen Swearninger.

Previous decisions, or acknowledgements, concerning leadership disputes or identification of tribal officials may have been issued without a request for a federal action by the Bureau of Indian Affairs; however, recent Interior Board of Indian Appeals (IBIA) case law reflects that the Bureau of Indian Affairs (BIA) is precluded from taking action on your request due to lack of a federal action.

Alturas Indian Rancheria v. Pacific Regional Director (54 IBIA 138, 138-39 (2011) states, in part:

In the absence of necessary Federal action by BIA on a specific matter, a BIA decision to recognize tribal officials, at least in the midst of a tribal government dispute, constitutes improper interference in internal tribal matters.

Coyote Valley Band of Pomo Indians v. Acting Pacific Regional Director, 54 IBIA 320, 320-21 (2012), states, in part:



At no time has BIA identified, as jurisdiction for taking sides in the tribal dispute, any required BIA action that prompted BIA's intervention and adjudication of issues of tribal law at the time of BIA's decision... BIA acted contrary to well-established precedent forbidding such intrusion into tribal affairs in the absence of required Federal action... BIA must refrain from taking sides and from issuing a decision, i.e., intervening in the dispute, until some specific Federal action by BIA is both necessary and requires that BIA identify a tribal representative.

Committee to Organize the Cloverdale Rancheria Government, Javier Martinez, Sarah Goodwin, Lenette Laiwa-Brown, Gerad Santana, and John Trippo v. Acting Pacific Regional Director, 55 IBIA 220, 223-224 (2012), states:

The Superintendent and Regional Director properly declined the Committee's request to issue a decision on the validity of the constitution adopted in the Committee-sponsored election because the Committee's request, standing alone, did not provide a jurisdiction for BIA to intrude into internal tribal affairs. As we recently held, 'BIA must refrain from taking sides and from issuing a decision, i.e., intervening in [an internal tribal government] dispute, until some specific Federal action by BIA is both necessary and requires that BIA identify a tribal representative.' Coyote Valley Band of Pomo Indians v. Acting Pacific Regional Director, 54 IBIA 320, 320-21 (2012); see also Pueblo de Dan Ildefonso Council of Principally v. Acting Southwest Regional Director, 54 IBIA 253, 25-60 (2012); Alturas Indian Rancheria v. Pacific Regional Director (54 IBIA 138, 138-39 (2011).

This Office recognizes there are internal issues within the Tribe; however, as demonstrated above, by recent IBIA case law, absent a request for a federal action BIA lacks the authority to intervene. Therefore, this Office nor the Superintendent, have any basis to respond to your request as these issues are considered internal tribal matters and are to be resolved in a tribal forum, not by the Department of the Interior, Bureau of Indian Affairs. Further, this Office encourages all parties to continue working with the Superintendent, Central California Agency, to obtain mediation in efforts to resolve this dispute.
