BACKGROUND AND PURPOSE

This full day training will provide participants with an understanding of the Native American cultural context, and promote the benefits of collaboration between state and tribal entities to improve outcomes for Native American families in the child welfare system. The training will focus on the nuts and bolts of the Michigan Indian Family Preservation Act (MIFPA) and federal Indian Child Welfare Act (ICWA), as well as the importance of fostering strong state-tribal relationships for vulnerable Native American children. Participants will learn about the key differences between MIFPA and ICWA, and will be given the opportunity to engage in discussion with a panel of experts.

TARGET AUDIENCE

This training was developed for all child welfare professionals, including court staff, jurists, prosecutors, attorneys, LGALs, CPS, DHS and private agency foster care workers, and tribes.

CONTINUED EDUCATION CREDITS
