3. TJMD was formed on February 25, 2010. I became the Transloading Operations Manager in June 2010. A true and correct copy of the North Dakota Secretary of State website is attached hereto as Exhibit A.

4. No later than May 16, 2011, I became the majority partner in TJMD. I notified Defendants that I own 51% of the partnership. A true and correct copy of the notice is attached hereto as Exhibit B.

5. TJMD is certified as a 51/49% Native American Owned Business with the Tribal Employment Rights Office ("TERO") for work within the Three Affiliated Tribes of the Fort Berthold Indian Reservation. A true and correct copy of information about TERO from the Three Affiliated Tribe's website is attached hereto as Exhibit C. A true and correct copy of the list of Certified Indian Companies with TERO is attached hereto as Exhibit D.

6. As of November 2012, I am the only partner in TJMD. I own 100% of the business.

7. Approximately 30-35 Native workers were displaced as a result of Defendants' conduct alleged in TJMD's Complaint.



In May of 1983, The Three Affiliated Tribes Council passed a Tribal Resolution that authorized the establishment of TERO within the Employment and Training Department of the Three Affiliated Tribes.

The Tribal Council approved a resolution and ordinance that enabled the tribe to exercise their inherent sovereign powers by imposing Indian Preference on employers working on or near the jurisdictional boundaries of the Three Affiliated Tribes.

Although Tribal ordinances are sufficient, it has been found that TEROs can also be utilized in monitoring and enforcing existing federal Indian Preference laws and regulations
