A write of Habeas Corpus 25 USC 1303

A. Complaint Against Fort Peck Tribal Jail Law enforcement
Staff naming the Detention center and Judicial Staff
naming Prosecutors, Judges and Public Defenders

B. Reasons for Complaint: I Bryce Glenn Granbois do
hereby ask this Federal court District of Montana to
investigate my incarceration in Tribal Jail on the
Fort Peck Indian Reservation for the following Reasons:

1. I have been incarcerated for 28 days on a drug related charge
I was given no Bond at the time I was arrested and
no bond during arraignment I still have no Bond.

2. I've put paper work in for public defender a number of times
and I still have not been given or even take to a public defender
yet 28 days

3. I was Given no legal telephone call for my first 2 week

4. When I was given a legal telephone I called tribal court

I was put in touch with Prosecutor Mary Lou Azure and I respectfully
Asked about a public defender and a bond hearing. She Stated to me
that I may not get a bond or a public defender cause of my
drug related charges she say we give no bond on this charges
we meaning tribal word I then told her that I felt my rights
are being violated she say "we tribal you know we do what we
want!" and that I ain't going to a thing about it anyway! I told
her that I was trying to go public with this trying to get
a hold of Reporters From Billings or Great Falls Paper to tell
them that we are living in a 3rd world country in the
state of Montana she then told me (Mary Lou Azure) Professional
Prosecutor For the Fort Peck tribes Then Say to me! 10F3

"That I Have A Big Mouth A Should watch my back" I ask her what? I was in total disbelief at what she said! She Mary Lou Azure Say it again

"That I have a Big Mouth and Should watch my back" So I Bryce Glenn Granbois am sitting here in the Fort Peck jail in lock down they put me in lock down ever since this was said to me I found out my Brothers Son/2003 Ford Explorer has been bent at my residence and have had all my windows broken out at my place My mother who lives next door to me who is a 76 year old elder of the Fort Peck tribes and my 17 year old daughter and little grand baby girl who live next door to my house are in fear for there safety and affaide to say who they saw burning up my brother Son i am sitting here Afaide of what could and may happen to my Family Cause of what I say in my Detencem Beg. I Beg this Federal Court For relief or Help please! As Soon as Possible

5. I Feel I am be wrongfully detained against my will

6. The Fort Peck tribes is Deeming me guilty without a fighting chance to prove my innocence

7. I Feel I am being Strong armed or pushed into some kind of conviction for them I am and will not do this for them...

FINAL PLea:

- I am a native american who believes and lives by the USA Constitution and we as a people are equal and should be treated that way... I respectfully ask this United States Federal Court For Help and For the Following relief
1. Immediate release from Fort Peck tribal Jail
 2. All chages be dropped because of my Constitutional rights being violated
 3. A investigation into the abuse of power and control over the people by the Fort Peck tribal board and the Fort Peck tribal Prosecutor Mary Lou Azure....
