NOW, THEREFORE, the parties, through their respective attorneys of record, do hereby 1 2 stipulate and agree that the Court may make and enter the following order: 1. This action is hereby dismissed with prejudice; 3 2. Defendants shall, within a reasonable time after the date this order is entered, pay 4 plaintiffs \$22,000 in full and complete satisfaction of any all claims for attorneys' fees, expenses and 5 any other costs incurred by them herein. 6 7 SO STIPULATED.
