MILS attorneys represent parents at all levels of the Michigan court system in cases under the Indian Child Welfare Act and Michigan Indian Family Preservation Act. cases. MILS has also provided representation for individuals in 11 of the 12 tribal courts in Michigan in a variety of tribal court cases, including child welfare, juvenile delinquency, garnishment, eviction, and criminal defense.





MICHIGAN INDIAN LEGAL SERVICES MAKES A DIFFERENCE

In a Tribal Court child welfare case, a MILS attorney helped a parent get her case successfully closed after several months of successful reunification with her children.

welfare case dismissed at the preliminary hearing.

A MILS attorney assisted a Tribal member in resuming parenting time visits with his daughter after



In three related Tribal Court child welfare cases, a MILS attorney represented a parent in negotiating a diversionary agreement regarding his cases and ultimately having all three cases dismissed.

We were contacted by a young couple with four children who had been living in an unsafe home for the past two years. The landlord filed a summons and complaint for eviction against the couple that was scheduled to be heard a week later. A MILS attorney negotiated a settlement with the Landlord that provided for an immediate dismissal of the lawsuit, a payment of \$1000 and allowed the tenants to remain in the home for one more month to find alternative housing.

We were contacted by an elder with questions about her pension. She had received a notice from her former employer that she could opt out of monthly payments for the rest of her life and, instead, receive a single lump sum payment. She was confused by the notice and so requested our help with the situation. With the help of a MILS attorney, the elder was able to make a fully informed decision.

In another Tribal Court child welfare matter, a MILS attorney assisted a Tribal member in getting a child

nonnative grandparents had obtained a guardianship without his knowledge and refused to allow him to see his child.

A MILS attorney drafted a Power of Attorney for Care of a Minor to help a tribal member avoid a potential child welfare case and kept the child out of foster care.

A MILS attorney is helping a client amend his birth certificate to accurately reflect the name of his true father so that he will be eligible to enroll into a Michigan Tribe.

A MILS attorney assisted a tribal member grandmother petition the state court for an order determining heirs so that she could use the court order to eventually access trust funds for her deceased son's three minor children for whom she provides.
