

2. I will support the Constitution of the Nooksack Indian Tribe in all respects.

3. I will abide by the rules established by the Nooksack Indian Council and the Nooksack Tribal Court.


4. I will at all times maintain the respect due the Tribal Court and its Officers.

5. I will not counsel or speak for any suit or proceeding which shall appear to me to be unjust, or any Defense except such as I believe to be honestly debatable under the law of the Nooksack Indian Tribe unless it be in defense of a person charged with a criminal offense.

6. I will employ such means only as are consistent with truth and honor and will never seek to mislead a Judge or Jury by any false statement.

7. I will abstain from all offensive conduct in the Community Court.
