Purpose

A legal research intern for the Native America Humane Society's Tribal Animal Legal Code Database Project shall assist in the research of tribal animal legal codes. Each intern will be assigned a region within the United States to research and gather animal codes from tribal communities. The gathered codes will then be compiled into a database, which shall be hosted by Michigan State University School of Law.

Interns shall report all findings to the Lead Project Coordinator and Project Manager. Interns shall assist for a minimum of ten (10) weeks through the summer of 2016.

Skills and Qualifications

Required abilities and dispositions:

- High personal motivation, self-management, and detail-orientation; ability to take responsibility in meeting deadlines and making progress without direct supervision.
- Strong verbal and written communications skills.
- Developed legal research skills.
- Capacity and motivation to learn research techniques and work routines quickly.

OUR APPROACH

NAHS works with tribes to improve the lives of community members and their animals through regular animal care, population management, and community activities. Our programs honor and respect the diverse cultures and traditions, as well as the sovereign status, of Native communities. Each tribe is unique and each has unique animal challenges. NAHS therefore works with each tribe to determine how best to resolve these challenges in a long-term, sustainable, and community-led fashion. The NAHS subscribes to the philosophy of One Welfare, which means that the health of a community's animals reflects the health of the community. When a community works to address animal welfare issues, there is a positive effect on the community's social issues as well. We believe that by healing our animals we can heal our people.

OUR VISION

NAHS will work with any tribe or indigenous community that requests assistance. Our Taking Care of the Animals framework for community programs offers three streams of engagement for communities at any level of capacity and interest: basic animal health care service provision, community organizing to empower community-led programs, or an engagement framework for larger change, Humane Community Development[©]. The core mission of Taking Care of the Animals is to get communities excited about their animals and to see animals in a different way — as valued partners in development and healing rather than a problem.
