PLEASE TAKE NOTICE that, on Monday, May 9, 2016, at 10:30 a.m., or as soon thereafter as the matter may be heard in the courtroom of the Honorable Marilyn L. Huff, Judge of the United States District Court for the Southern District of California, Courtroom 15A, located at 333 West Broadway, Suite 1510, San Diego, CA 92101. Defendant Blue Lake Casino & Hotel ("BLC&H"), which is wholly owned and operated by the Blue Lake Rancheria ("Tribe"), a federally recognized Indian tribe, shall make a special appearance for the purpose of moving the Court, pursuant to Fed. R. Civ. Proc. 12(b)(1), for an order dismissing Plaintiff's complaint in its entirety for lack of subject matter jurisdiction, pursuant to Fed. R. Civ. Proc. 12(b)(2) for an order

dismissing Plaintiff's complaint in its entirety for lack of personal jurisdiction, and pursuant to Fed. R. Civ. Proc. 12(b)(3) for an order dismissing Plaintiff's complaint in its entirety for improper venue.

The motion is made on the following grounds: (1) BLC&H is wholly owned and operated by the Tribe and, therefore, it enjoys sovereign immunity from unconsented suit absent congressional abrogation or waiver of that immunity; (2) no such abrogation or waiver has occurred with regard to this case; (3) the Tribal Court is a governmental subdivision of the Tribe and is similarly cloaked in the same immunity enjoyed by the Tribe and BLC&H; (4) the Tribe's sovereign immunity extends to Lester J. Marston, as Chief Judge of the Tribal Court, and Anita Huff, as Clerk of the Tribal Court, who, at all times relevant to this action, have acted in their official capacities and within the scope of their authority; (5) Acres has failed to exhaust his Tribal Court remedies and an exception to the exhaustion rule does not apply; and (6) the United States District Court for the Southern District of California is an improper venue for this action, as no part of the events or omissions giving rise to Acres' claims occurred in this District.

This motion is based on all pleadings and papers already on file herein, the memorandum of points and authorities filed in support of this motion, the declarations of Thomas Frank, Robert Pollard, Anita Huff, and Yasmin Frank filed in support of this motion, and such other pleadings, papers, argument, or evidence that may be introduced prior to or at the hearing on this motion.
