In the Matter of a Petition to Terminate the Special Provision of Legal Services by Qualified Attorneys From Outside North Dakota

- [1] The Judges of the South Central Judicial District request that the Supreme Court terminate the special provisions which allow attorneys not licensed in North Dakota to provide legal services in North Dakota to represent defendants charged as a result of protest activities connected to the Dakota Access Pipeline.
- [2] Only attorneys actively representing a client and listed as attorney of record on the date of the filing of this petition should be allowed to continue under the special provisions adopted by the Supreme Court on January 18, 2017. At the present time, 16 attorneys admitted under the special provision are attorney of record in active cases. Attorneys whose names have been added to the list of attorneys who may practice under the special provisions but who are not attorney of record in a pending case should not be allowed to practice under the special provisions.
- [3] There is no longer any justification for dispensing with the general rules for pro hac vice practice. New cases are no longer being filed, and there is no indication that local attorneys are unavailable to provide representation. Of the 36 attorneys who have been admitted under this provision,11 have never been attorney of record in any of the cases.
- [4] We have noted that many of the attorneys practicing under the special provisions have associated with attorneys who are licensed in North Dakota but maintain their primary office outside the State of North Dakota, making it impractical for a judge to require the presence of the North Dakota attorney even when out-of-state attorneys are unfamiliar with local rules

and procedures. Eighteen of the attorneys admitted under this rule, or one-half of the attorneys admitted, have an associate attorney who does not have an office in North Dakota.

- [5] There is no longer a need which requires waiver of the pro hac vice filing fee in these cases.
- [6] For those reasons, we request that the special provisions adopted to allow for attorneys not licensed in North Dakota be terminated except for those attorneys who are actively engaged in defense of a client.
