# <u>DUTIES AND RESPONSIBILITIES</u> (Examples may include but are not limited to the following).

- Provides legal advise and prepares formal legal opinions on a wide range of problems dealing with Criminal Cases, which are filed through the Tribal Courts; interview witnesses, prepare for trial, present evidence of criminal violation.
- Consult and interview Law Enforcement Officers, tribal member and other Law Enforcement Officers, drafting needed information as applicable.
- Gathers and analyzes evidence in cases and reviews pertinent decisions policies, regulation and other legal matters pertaining to cases; presents evidence against accused for indictment or released of accused as required; appears against accused in a court of law and presents evidence before Judge or other judiciary and jury.
- Coordinates extensive legal research for courts, Tribal matters, on Criminal matters between the Tribe and individuals to assist the drafting of Criminal system.

## MINIMUM QUALIFICATIONS

### Required knowledge, skills, and Abilities

- Thoroughly knowledge of Tribal codes and ordinances.
- Thoroughly knowledge of Criminal and Civil Law and States statutes.
- Considerable knowledge of Tribal Law and Order Code, general provision of Ute Indian rule of Criminal Procedure.
- Ability to apply legal principles and knowledge of individual cases and problems.
- Ability to analyze and evaluate facts and evidence and to apply them individual cases and problems.
- Ability to maintain effective working relationship with Tribal Employees, Administrative and Court officials and general public.

## **EDUCATION & EXPERIENCE**

- Jurist Doctorate/Law degree from an accredited law school.
- Supplementary coursework in Criminal Court procedures.
- Two year experience as Prosecutor or related field.

## NECESSARY REQUIREMENT

- Pass a Criminal Background Check
- Must pass a pre-employment drug test
- Must have a valid Utah State Driver's License and must be able to obtain a Tribal License.
- Must attend training from Tribal Attorneys and other Law Agencies.
- Must successfully complete a three month probationary period during which incumbent will be evaluate for satisfactory performance of typical duties listed.
- Must be licensed to practice law in any state, preferably in Utah.
