considered, but they are weighed with other equally significant factors: personal accomplishments, professional goals, and the capacity to work conscientiously and independently as needed. Candidates with interest in specific Indian law projects are encouraged to bring their proposals to the firm. Membership in the California Bar, or willingness to obtain membership in the California Bar or Bar of another state, is a significant factor in the firm's evaluation of candidates.
