



Dear Dwight:


Judge Viken sentenced you to 14 months imprisonment. The bottom of your guideline range was 18 months, and he cut 4 months in recognition for the time you sat in AOF. At the time of your sentencing, in January of this year, you had approximately 9 months of credit in federal custody. Therefore, you had approximately 4 months left to serve. Your letter to myself and to the court doesn't indicate what out date the BOP has given you, which would be useful information.
