A vote forced upon our people which
was outvoted. All elections were
supposed to include Data and

Analysis of a Impact Study which
was never Done But again forced
upon our Blackfoot Tribal Members.
we filed with Montana State Court
but in 2019 now we never had a
hearing that would follow laws of
Impact Study and Analysis of outcome
for the betterment of our Blackfoot
Tribal Members only that Montana
state would take our water
rights for a Meagher \$175 million
Dollars with senior water rights
to rush our water off this Reservation
A payment of Peanuts, no mention of
water usage since 1885 came

Ball Treaty along with water usage
in Canada and throughout United
States we are the Headwater
keepers the Blackfoot Nations along
with Sit Sika Pikuni Bloods Kainai also
Fort Belnap according to our Larne Ball
Peace Treaty. None of our Arguments
have been addressed only illegal
signatures and documents been
overlooked and continue to this day.
