



# Mitchell Hamline School of Law Gateway to Legal Education



#### **Mitchell Hamline School of Law**

- Tradition of nontraditional education
  - Nights and weekends
  - Online/hybrid learning
- Commitment to inclusion
  - Students of color are 28% of incoming class
  - Among 2018-19 1Ls, second-highest enrollment of indigenous students in the country



#### MHSL Gateway to Law Program

- MHSL partners with undergraduate institutions with high percentages of POCI students, Pell Grant recipients, firstgeneration college-goers
- All tribal colleges and universities are eligible partners




#### MHSL Gateway to Law Program

- Deliver online pre-law curriculum to target undergraduate institutions
  - Introductory legal education
  - Health law
  - Federal Indian law (in progress)
- Paired with law student/lawyer mentor





- Identify goals
  - **Mashkawendami**: Giving someone a strong resolution, letting someone think firmly (empowerment)
- Dialog with key staff and faculty
