MOTION FOR TEMPORARY RESTRAINING ORDER

Erin Fisher, Richard Fisher, and Erin Fisher, as Next Friend and Natural Mother of Minor Child, A.C. (collectively "Plaintiffs"), for their motion for temporary restraining order state as follows:

- 1. Plaintiffs filed the instant lawsuit asking this Court to declare that ICWA §§ 1912(d), (f), 1914, 1915(a), and the 2016 Regulations implementing these provisions, do not apply in purely private actions for termination of parental rights and stepparent adoptions like this one.
- 2. Plaintiffs further requested a declaration that such an application of ICWA is unconstitutional under the Equal Protection and Due Process provisions of the Fifth and Fourteenth Amendments to the United States Constitution, and the Privileges or Immunities Clause of the Fourteenth Amendment.
- 3. Plaintiffs requested that this Court permanently enjoin Defendants from invoking ICWA §§ 1912(d), (f), 1914, 1915(a), and the 2016 Regulations, in response to any private termination and stepparent adoption matter that Plaintiffs should choose to file.

- 4. Defendant Jason Cook recently filed a motion in state court seeking after more than two years without any contact to reinstate visitation rights with A.C.
- 5. Plaintiffs move that the Court enter a temporary restraining order stating that ICWA does not require visitation to commence in such a private family dispute, or in the alternative, preventing Cook from seeking visitation until this Court determines the applicability or constitutionality of ICWA.
- 6. Allowing Cook to suddenly reappear in A.C.'s life will certainly cause severe emotional harm to a child, his mother, and the person he considers his dad.
- 7. The harm to the Fisher family is far greater than to Cook, who has made little effort over A.C.'s life to be involved.
- 8. The Fisher family will likely be successful on the merits of their claim that ICWA does not apply here, or is unconstitutional, and thus there will be no reason for Cook to have visitation.
- 9. The public interest of protecting a vulnerable child and his family is far more important than reinstating visitation rights for an unknown amount of time while the question of the applicability of ICWA weaves its way through the court system.
- 10. In support of this motion, Plaintiffs rely upon the affidavit of Erin Fisher, which is attached as an Exhibit hereto, and an accompanying memorandum of law, which are both incorporated by reference in their entirety herein.

WHEREFORE, Plaintiffs further pray that the Court enter a temporary restraining order stating that ICWA does not require visitation to commence in such a private family dispute, or in the alternative, preventing Cook from seeking visitation until this Court determines the

applicability or constitutionality of ICWA, and for such further and additional relief as this Court may deem appropriate.

AFFIDAVIT OF ERIN FISHER

I, Erin Fisher, having been duly sworn, do hereby state the following under oath:

- 1. My name is Erin Fisher. I married Jason Cook on September 25, 2004. Jason and I separated November 26, 2010 and divorced on August 3, 2011. I have attached a copy of our Decree of Divorce as Exhibit 1.
- 2. I became pregnant with our child, A.C., in August 2008. During the pregnancy, Jason had minimal contact with me. He worked away from home and lived separately from me.
- 3. He was absent from my life and did not attend any doctor's appointments or checkups during the pregnancy.
- 4. My son, A.C., was born May 14, 2009.
- 5. Before the pregnancy, Jason commenced an extramarital affair that continued throughout our marriage.

- 6. After we separated in November 2010, Jason no longer provided financial support for me or A.C. At the time, I was a full-time nursing student, I supported myself and A.C. by exhausting my savings.
- 7. Per the divorce decree, Jason was permitted to visit with A.C. every third weekend; however, Jason routinely didn't exercise his visitation rights. Ex. 1 at 2.
- 8. In March 2016, after Jason was arrested on drug charges, the court entered an Emergency Ex Parte order for supervised visits with Jason's mother present every Wednesday evening for three hours and every other Saturday for 5 hours. I have attached a copy of this Order as Exhibit 2.
- 9. Jason cancelled six visits between March 23, 2016 and August 10, 2016. All visits were cancelled by Jason after August 17, 2016.
- 10. A.C. has few, if any, fond memories from visitation with Jason. For example, during supervised visitation, Jason's mother left A.C. alone with Jason so that she and her husband could go out for dinner. When I arrived to pick him up, A.C. was visibly upset. He told me that he was left alone with Jason and was upset because he knew that was against the rules. Later that evening, Jason's mother confirmed A.C.'s account of the day.
- 11. A.C.'s memories of Jason are mostly of times that Jason slept on the couch the entire visit.

 If not asleep, Jason would leave A.C. to go outside and smoke cigarettes or play on his phone.
- 12. Prior to the supervised visits, A.C. recalls a time that Jason locked him in a bedroom while his "friends" came over. His friends stayed and smoked inside the apartment while A.C. remained locked in a back bedroom. A.C. still remembers the smell of the smoke, the noise, and commotion from that day.
- 13. I learned from my review of public records that Jason was incarcerated from March 2017 to October 2018. I have attached a copy of Jason's Sebastian County Inmate Summary as Exhibit

- 3 and his Sebastian County Custody Record as Exhibit 4. Jason has made no attempt to visit A.C. since his release from jail in October 2018.
- 14. Jason has only tried calling A.C. a handful of times over his entire ten years of life.
- 15. I learned from my review of public records that in April 2016, Jason was arrested in Arkansas for contempt of court for failure to pay child support to me. Ex. 3. He was arrested again for contempt of court for failure to pay child support on February 1, 2017. Ex. 3.
- 16. Jason has not consistently paid child support to me and has not paid any child support for a period of 28 months, which includes 24 consecutive months from November 2016 to November 2018. However, I received \$1,500 on February 10, 2017 from his bond for contempt of court. I have attached a copy of his Child Support Verification as Exhibit 5.
- 17. In February 2016, A.C. and I were visited by a state social worker from the Arkansas Department of Human Services. DHS was investigating Jason's relationship with his other known child, born out of wedlock to the same person he had an affair with during my pregnancy. I learned from the social worker that his other child was found to be neglected by Jason.
- 18. I began dating Richard Fisher in June 2012, and we were married June 28, 2013.
- 19. Richard and A.C. have a steadfast father-child bond, as Richard is the only father A.C. has ever known. A.C. began referring to Richard as "daddy" in 2014. A.C. only refers to Jason by his first name.
- 20. Richard Fisher has been a father to A.C. through every major milestone in A.C.'s life, as far back as seeing him off for his first day of 3-year-old preschool at Christ the King School on August 16, 2012. Richard, A.C., and I celebrate all holidays together and take vacations together as any family would.

- 21. Richard has been an integral part of A.C.'s participation in sports, including soccer, baseball, and swimming. Richard helped coach A.C.'s Little League baseball team and taught A.C. how to swim. A.C. has since competed in multiple swim meets in Arkansas. In 2015, Richard taught A.C. how to ride a horse.
- 22. Richard takes an active interest in A.C.'s education. He helps him with school projects and homework.
- 23. In June 2016, we had a son, with whom A.C. shares a strong sibling bond.
- 24. There is no relationship to reestablish or reunify between Jason and A.C. Visitation would be psychologically damaging, as A.C. is terrified of seeing Jason. When I told A.C. that Jason had been released from prison he became very upset and started crying. A.C. is genuinely scared that Jason will come to our home or to his school in an effort to see him.

DECREE OF DIVORCE

Now on this <u>3kd</u> day of <u>Quegust</u>, 2011, this matter comes on for hearing. The Plaintiff, Erin E. Cook, appears by and through her attorney, Joseph C. Self. The Defendant, Jason M. Cook, appears not after having executed a Waiver of Service and Entry of Appearance. The Court, after hearing testimony, viewing evidence and being well and sufficiently advised, does find the following:

- 1. That the Plaintiff is a resident of Sebastian County, Arkansas, Fort Smith District and has been for more than sixty (60) days prior to the filing of this action. The Plaintiff's cause of action occurred in the last five (5) years. This Court has jurisdiction over the parties hereto and the subject matter herein. The venue is proper.
- 2. That the parties were married on or about September 25, 2004, and lived as husband and wife until on or about November 26, 2010, at which time they separated and have lived separate and apart since that time.

- 3. That the Plaintiff shall be awarded an absolute divorce from the Defendant on the grounds of general and personal indignities.
 - 4. That one child has been born of the parties' marriage, namely,

, DOB:05/14/09. The Plaintiff shall be awarded custody of the minor child subject to the Defendant having visitation as set forth in this Court's Standard Order Regarding Visitations and Other Related Matters which is attached hereto and incorporated herein by reference. Due to Defendant's work schedule, the Court's Standard Order for Child Visitation and Related Matters is hereby modified to allow Defendant to have visitation every third weekend. Defendant shall not have extended summer visitation at this time. The Defendant shall pay child support to the Plaintiff in the amount FOUR HUNDRED FIFTY DOLLARS (\$450.00) bi-weekly. The Plaintiff's child support obligation shall be automatically withheld from his wages by his employer. The Defendant shall execute all necessary documents to direct his employer to automatically withhold his child support obligation from his wages. The Defendant's employer shall automatically withhold the Defendant's child support obligation from his wages and shall forward that amount to the Clearinghouse for Child Support Payments, P.O. Box 8125, Little Rock, AR 72203. The Defendant's employer shall note this case number "DR-2011-446" on the check and the check shall be made payable to "Erin Cook". The Defendant shall be responsible for any and all fees associated with the processing of his child support obligation. This Court's Standard Order Regarding Medical and Dental Expenses shall apply to the parties and is attached hereto and incorporated herein by reference, with Defendant carrying the

minor child on his insurance through his employer.

- 5. That the parties own real property located at 901 South 26th Street, Fort Smith, Sebastian County, Arkansas, and Plaintiff shall be awarded the real property subject to any indebtedness thereon. Defendant shall quit claim his interest in said real property to Plaintiff.
- 6. That Plaintiff is awarded the 2009 Nissan Murano, subject to any indebtedness thereon. Defendant is awarded the 2009 Nissan Titan and his motorcycle, subject to any indebtedness thereon. The parties have already made equitable distribution of their other personal property.
- 7. That the parties acquired certain marital debts which the parties have made equitable distribution. Each party is responsible for any indebtedness incurred in their names after the date of the separation, and shall be responsible for their respective student loans.
 - 8. That each party is awarded any IRA or 401k in his or her own name.
- 9. That the Defendant shall pay Plaintiff the amount of THREE THOUSAND DOLLARS (\$3,000.00) for the bills for the month of July. If this Decree is filed before the end of July, Defendant shall pay Plaintiff the amount of THREE THOUSAND DOLLARS (\$3,000.00) less the court ordered child support.
- 10. That the parties shall alternate years to claim the minor child as a tax deduction, with Plaintiff claiming the tax deduction the first year.
 - 11. That Plaintiff's name is changed to Erin England Cook.

- 12. That the temporary restraining order which enjoins the parties from harassing or bothering each other shall be made permanent and binding upon the parties.
- 12. That this Court shall retain continuing jurisdiction over the parties hereto and the subject matter herein to make such other further orders as may be deemed necessary in the future.



TEMPORARY ORDER

Now on this 8th day of March, 2016, comes before this Court the plaintiff's Application for Entry of Ex Parte Order and Motion to Restrict Visitation. The plaintiff, Erin E. Cook, now Fisher, appearing in person and with her attorney, Roy Gean, III, and the defendant, Jason M. Cook, appearing in person and with his attorney, Joel W. Price. The Court, having previously entered an Ex Parte Order in response to the verified Application for Entry of Ex Parte Order, considers further the issues regarding the defendant's visitation with the parties' minor child, , born May 14, 2009. The Court, having considered the plaintiff's pleadings and the defendant's Response, having considered the testimony of the plaintiff and the testimony of Kellie Middleton, the mother of the defendant, Jason M. Cook, and otherwise being fully advised in the premises, finds:

I

That this Court has jurisdiction over the parties and subject matter hereof and proper venue lies herein.

II

That the parties hereto were divorced by Decree of Divorce dated and entered on August 3, 2011.

Ш

That, in the aforesaid Decree, the parties' minor child, . , born May 14, 2009, was placed in the custody of the plaintiff subject to the visitation privileges of the defendant.

IV

That, due to circumstances having materially and substantially changed, the Court entered an Ex Parte Order as aforesaid. That the Court, having considered the aforesaid testimony and the pleadings herein filed, finds that the defendant's visitation should continue to be supervised.

V

That the defendant shall be permitted to visit with the aforesaid minor child every other Saturday from 10:00 a.m. to 3:00 p.m. and every Wednesday from 5:00 p.m. to 8:00 p.m. That all visitation shall be under the supervision and presence of the defendant's mother, Kellie Middleton. That, while the aforesaid Kellie Middleton is the supervisor of said visitation, it is understood that the visitation is the defendant's. That the plaintiff shall provide all transportation of the minor child at the beginning and at the end of each visitation of the defendant.

VI

That, furthermore, the defendant is not allowed to transport the aforesaid minor child at any time.

VII

That, in the event the plaintiff suspects drug use by the defendant, the plaintiff is permitted to request a drug test by the defendant. That the defendant must comply within forty-eight (48) hours to take the aforesaid test. That, in the event the defendant proves positive for drugs on the aforesaid drug test, the visitation of the defendant shall immediately cease. That should the defendant test negative on the drug test, then the plaintiff shall reimburse the defendant for the costs of the aforesaid test.

VIII

That the defendant is prohibited from using drugs and is prohibited from being under the influence of such during the time that he is with the aforesaid minor child.

IΧ

That, furthermore, neither the supervisor or any other party connected with the defendant shall speak negatively about the plaintiff or the plaintiff's family members and likewise, the plaintiff shall be prohibited from making any negative or derogatory remarks about the defendant or the defendant's family members in the presence of the minor child. That the parties are not to discuss this case with the minor child. That the defendant is prohibited from associating with any individual who is a known felon or is known to partake or involve himself or herself in drugs or is known for such in the past.

X

That in the event the minor child is ill and cannot make the scheduled visit without jeopardizing the child's health, then the visitation shall be cancelled and subsequently rescheduled.

XI

That this Temporary Order shall be reviewed after ninety (90) days from the date hereof to determine whether the visitation as herein outlined will continue.

XII

That this Court retains jurisdiction over the parties and subject matter hereof for the purpose of entering further Orders as may be necessary.


