FINAL JUDGMENT AND ORDER OF DISMISSAL

This matter is come before the court on the Settlement Agreement and Release between the United States and Claimant Pueblo of Pojoaque, Claimant Thomas F. Gede, Trustee for Pueblo of Pojoaque Gaming Funds Trust, and the State of New Mexico. The Court, having reviewed the agreement and being fully advised in the premises, finds that entry of this Judgment and Order is appropriate.

THE COURT THEREFORE ORDERS AND ADJUDGES AS FOLLOWS:

1. The United States, through the United States Marshals Service, will release sixty percent of the Defendant Funds, that is, \$6,077,308.62, and sixty percent of the interest accrued upon the Defendant Funds, that is, \$155,856.08, to the State of New Mexico. The total amount of funds to be released to the State of New Mexico will be \$6,233,164.70.

2. The United States, through the United States Marshals Service, will release forty percent of the Defendant Funds, that is, \$4,051,538.80, and forty percent of the interest accrued upon the Defendant Funds, that is, \$103,904.06, to Claimant Pueblo of Pojoaque. The total amount of funds to be released to Claimant Pueblo of Pojoaque will be \$4,155,442.86.

3. This case is dismissed with prejudice.

4. Each party will bear its own costs and attorney's fees in this case.


