Intervenor-Plaintiff The Chicago Transit Authority Retiree Health Care Trust ("RHCT") and Defendant U.S. Bank National Association ("U.S. Bank") hereby submit the following joint stipulation for dismissal with prejudice:

It is stipulated and agreed by and between the parties hereto, through their respective counsel, that RHCT's causes of actions and claims against U.S. Bank in the above-entitled action, and U.S. Bank's counterclaim and causes of action against RHCT in the above-entitled action, shall be, and hereby are, dismissed with prejudice and without costs, expenses or attorneys' fees to any party; provided, however, that the Court shall retain jurisdiction to resolve any disputes arising out of or related to the settlement between RHCT and U.S. Bank.
