9.) The Defendants stole a home from someone who lived in a Federally funded HUD unit because she investigated the Defendants' abuse of authority by the Chairlady of the Tribal Counsel, as she stole Federal funds to remodel her private home.

10.) The Defendants have no regard for the Court, Commercial Code, or the Public Trust as they steal land and kidnap people who try to protect their rights and property.

11.) The Defendants' Counsel, Sean Copeland, Esq. is demonstrating that he's part of this conspiracy to traffic Plaintiff's property.

12.) Attorney Sean Copeland knows of the crimes and actions by the Defendants against Plaintiff, as he knows Plaintiff owns the land, and he knows the Tribal Council has no right to transfer easements for construction on Plaintiff's land to a Foreign Corporation, and they've gone forward with the construction while knowing the Case is still open at the U.S. District Court.

18.) Plaintiff will be filing a Complaint to the Minnesota Lawyers Professional Responsibility Board for Attorney Copeland's actions against Plaintiff while he knows she owns the land, and he wants to dismiss the Case knowing the Tribal Council will continue to harm Plaintiff, and he knows there is no law there.

19.) Sovereignty and immunity does not belong to a limited liability corporation or its members who kidnap, harm and rob Plaintiff.

20.) The Defendants claim they can continue to harm Plaintiff without restraint simply because they're not to be held accountable or responsible for Felonies.
