

Employment Opportunity

Mitchell Hamline School of Law seeks to hire a tenure-track or tenured faculty member with substantial practice or teaching experience to co-direct and teach in its nationally known Indian Law Program beginning in the summer or fall of 2020.

Our law school is located in St. Paul, Minnesota, on the Indigenous homelands of the Dakota Oyate. Eleven federally recognized tribes, including four Dakota and seven Ojibwe tribes, remain within the State. Just a few miles away from the law school is the City of Minneapolis, which was the birthplace of the American Indian Movement, and continues to boast one of the largest urban Indian populations in the country.

Mitchell Hamline is committed to serving these local Indigenous communities while continuing to expand its national reach, particularly through its unique program of blended legal education (an approach that combines online and on-campus instruction). Every student admitted to our blended program who is an enrolled member of federally recognized tribe or who has a demonstrated interest in practicing in the field of Indian law receives a Tribal Justice Scholarship, which is designed to make law school affordable for students who wish to work in or for Native communities. The Indian Law Program currently offers students courses in Federal Indian Law (offered every semester), Introduction to Tribal Law (offered every spring), and Advanced Indian Law (offered every fall). Students in both the in-person and blended programs are also able to participate in the year-round Indian Law Impact Litigation Clinic, which serves as lead counsel to tribes in treaty rights litigation in federal and state courts, and submits amicus briefs on behalf of tribes and tribal organizations in cases pending before the U.S. Supreme Court.

The ideal applicant for this position will have a strong regional or national reputation in the area of Indian law, experience teaching at an ABA accredited law school, and one or more scholarly publications. The candidate's teaching package will include Introduction to Tribal Law in the blended program, one or more additional Indian law courses that fit the applicant's area of interest and experience and the program's needs (either clinical or doctrinal), and one core doctrinal course (first-year or otherwise). Applicants must have a J.D. degree and at least eight years of professional practice or teaching experience.
