Indian Preference

Preference shall be given to qualified Indian enterprises and organizations. Any firm seeking Indian preference in this RFP must provide evidence it is not less than 51% Indian owned and controlled.

SCOPE OF WORK

- Echaga seeks an attorney or law firm to provide general legal counsel services with a focus on corporate counsel and economic development matters, including but not limited to the following:
 - Draft corporate documents as requested by the Board of Directors.
 - Assist with Board and Shareholder meetings.

- Assist with economic development opportunities review proposals, draft documents, prepare presentations, etc.
- Assist with SBA 8(a) government contracting opportunities.
- Draft memoranda on proposed legislation, comment letters, and prepare testimony for congressional hearings.
- Draft legal opinions.
- Prepare documents for creating subsidiary entities, acquiring business entities, entering into joint ventures or other business relationships with outside entities.
- Conduct due diligence pursuant to Tribal Council Ordinance(s).
- Represent Echaga in court and administrative hearings.
- Provide general legal advice.

SECTION III - PROPOSAL EVALUATION

PROPOSAL EVALUATION

A. Criteria

Echaga will evaluate proposals based on the needs of the corporation. The following criteria will be used in evaluating each of the proposals:

- 1. Compliance with specifications.
- 2. Cost.
- 3. Experience and Qualifications.

B. Review of Proposals

The Board of Directors will interview candidates and make a selection. Unless otherwise notified, the interviews will be via Zoom or another video-conferencing method. The Board will choose the proposal(s) that best fits the needs of Echaga Corporation and is not obligated to award the contract based on cost alone nor is to award only one contract.
