Justice Dennis W. Arrow Justice John J. Kocher Justice Ryland L. Rivas Justice Lindsay G. Robertson Materially, the Fredericks Law Firm's legal-fees claims fall into three categories.

Α.

Its first set of claims against the Tribes is for \$1,013,018.83. That is the amount it billed to the Tribes for work done for the Second Legislature from April 2008⁴ to December 31, 2009, and for which it claimed the right to be paid pursuant to a December 30, 2009 Order of this Court that recognized its right to be paid "reasonable attorney's fees" where its work was "reasonably necessary" for the Legislative Branch to have effectively functioned.⁵

The January 28, 2019 Trial Court decision that we review today described those fees as the "ordered fees," and we adopt that description as both accurate and useful.

В.

The second of its claims is for either \$30,086.05 or \$30,636.05,6 which the Fredericks Law Firm billed for work done for the Legislative Branch in January and February 2010.

We take judicial notice that the Third Legislature replaced the Second Legislature on Saturday, January 2, 2010, and that the Third Legislature vigorously opposed many of the things that the Second Legislature favored (and vice-versa). We also take judicial notice that rather than hiring a law firm to represent it, except for the short "holdover" contract period, the Third Legislature was at all material times represented by the Office of Legislative Counsel [though then-Governor Boswell stripped that office of some of its lawyers by purporting to unilaterally appropriate them in early February 2010]."

To whatever extent that either or both attorneys and/or sets of attorneys have not been paid REASONABLE ATTORNEYS' FEES for the representation described in Part IV, we direct the Governor to pay such attorney's fees, as having been "reasonably necessary for the Executive and Legislative Branches (and the Election Commission) to effectively operate" from April 4, 2006 until the close of business on December 31, 2009.
