### I. MOTION

Pursuant to Federal Rule of Evidence 201, Plaintiffs-Appellants Robert Doucette, Bernadine Roberts, Saturnino Javier, and Tresea Doucette (collectively, "Doucette"), move the Court to take judicial notice of one new email document, which confirms that Defendants-Appellees U.S. Department of the Interior, et al. ("Interior") knew by June 18, 2018 of at least four inculpatory emails that the agency did not file with the District Court as ordered by February 21, 2019 or otherwise as required by 5 U.S.C. § 706. SER 31; Declaration of Gabriel S. Galanda in Support of Motion to Take Judicial Notice (December 14, 2020) ("Galanda Decl."), Ex. A. Those four emails between Interior Counselor Kyle Scherer and the Nooksack holdover Council's lobbyist, Robert Porter, reveal precisely how and why Interior issued the Recognition Decision on March 9, 2018. ER 0893-0899 (collectively, "Scherer-Porter Emails"). The new email confirms Interior's knowledge of the Scherer-Porter Emails and undercuts the agency's stated explanation for its failure to produce those decisional documents. Doucette first learned of the new email on May 29, 2020, when Interior produced the document pursuant to lead Plaintiff-Appellant Robert Doucette's January 23, 2020, Freedom of Information Act ("FOIA") request. Galanda Decl. at ¶ 2.

#### II. DISCUSSION

### A. Document To Be Noticed And Its Relevance To This Appeal

Doucette argues in this appeal that Interior withheld the Scherer-Porter Emails because they showed the extent of Porter's access and influence at Interior and reveal precisely how and why Interior issued the Recognition Decision on March 9, 2018—specifically, to advantage third-party RICO appellant-defendants as they appeared before this Court in related litigation that very day. Dkt. # BRIEF at \_; ER 0097, 0108. Interior claims it was "harmless error . . . to omit these email messages from the administrative record." Dkt. # 50 at 14-15. Interior suggests that Scherer's transfer between Interior's Office of Assistant Secretary—Indian Affairs ("ASIA") and its Office of the Solicitor "could explain why these records were not found" or produced as part of the AR. *Id.* at 15. The new email reveals that Interior and Scherer knew of the Scherer-Porter Emails notwithstanding any personnel transfer, but concealed them from Doucette and the District Court. Galanda Decl., Ex. A.

### B. Applicable Legal Standard

Federal Rule of Evidence 201 provides that the Court "may judicially notice a fact that is not subject to reasonable dispute because it: . . . can be accurately and readily determined from sources whose accuracy cannot reasonably be questioned," and may do so ". . . at any stage of the proceeding." Fed. R. Evid. 201(b), (d). This Court has taken judicial notice for the first time on appeal of facts developed after the appeal was filed, where those circumstances "may affect" the Court's consideration of the issues presented on appeal. *See, e.g., Bryant v. Carleson*, 444

F.2d 353, 357 (9th Cir. 1971); *cf.* 21B Wright & Miller, *Fed. Prac. & Proc. Evid.* § 5110.1, at 301-02 (2d ed. 2005) (taking judicial notice of a fact outside the record "seems to be favored when the appellate court needs to take account of developments in the case subsequent to the proceedings in the trial court."); Fed. R. Civ. Proc. 62.1.

Doucette seeks judicial notice of facts whose accuracy can readily be determined from their source and whose accuracy cannot reasonably be questioned. The single email document subject to this Motion is a record produced by Interior in response to Doucette's FOIA request. The United States is a reliable source of accurate information related to their own records, and they possess the legal obligation to be accurate in response to FOIA requests. *See* 5 U.S.C. § 552. These facts were developed after Doucette filed his appeal on March 23, 2020 through no fault of Doucette, who filed his FOIA request on January 23, 2020 and did not receive a response until May 29, 2020. Galanda Decl. at ¶ 2. The information may affect the Court's consideration of the issues on appeal because they bear on Interior's failure to produce the whole AR as required by the Administrative Procedures Act ("APA") and the District Court's Order. 5 U.S.C. § 706; SER 31.

#### III. CONCLUSION

For the reasons above stated, Doucette respectfully requests that the Court exercise its discretion and take notice of the single email document identified herein. *See* Galanda Decl. Ex. A.
