 1. Within Aaron Payments motion to dismiss, admission Michilimackinac descendants have been enrolled to the Sault Tribe.
 2. See. (The governor of Michigan's answer) it identifies Sault Tribe is party to the Treaty of Washington D.C. & later states I have no rights and a beneficiary of nothing.
 3. Facts: I am enrolled to the Sault Tribe; it's my Grandfathers legible signature as the primary chief on the Treaty of Washington D.C. That is currently associated with Sault Ste Marie Tribes Federal Recognition.
4. Aaron Payment has oversight; Michigan has just given written proof in my opinion of classic assimilation and deprivation of my Federal Rights. Pursuant to Michigan Compiled Law MCL 762.2 All Citizens allows Michigan to deprive our Citizenship! Furthermore U.S.C. Title 25 cfr 83.7 Federal recognition is for New Tribes!
5. The 11 United States Treaties part of the evidence is my Federal Rights by signature!


