Origins of our enrollment Sault Ste. Marie tribe of Chippewa Indians, a tribe organized in 1975 under the Indian Reorganization Act, 25 U.S.C. § 476, intervened in this action and filed a complaint against Michigan on December 12, 1975. In its complaint, the tribe alleged a treaty-protected, reserved right to fish in Lake Superior free from state regulation. On June 17, 1976, the Chippewa tribe filed an amended complaint in which it alleged an exclusive right to fish in the waters reserved to the Indians in the Treaty of 1836. The plaintiffs' pleas for relief are grounded in the Supremacy Clause of the United States

Constitution, Article 6, Clause 2. the State of Michigan has know all along The Sault Ste Marie tribe, a corporation of Bay Mills Indian Community enrolled signatory Michilimackinac descendant's whom where party to United States treaties, (ICC) Indian Claims Commission Docket 18E 57, 58 and 364 Judgment funds. Both bay mills & Sault tribe collected federal dollars under these dockets, however the family members whom the funds were intended have never received any payments or funds nor actively made claim to mineral rights to date. (See. Sault Tribe Resolution 2004-121 Federal Acknowledgment or Reorganization of Mackinac Descendants) In the event Mackinac obtains its federal recognition, members of the Sault Tribe shall not be dissenrolled solely because of eligibility for enrollment in the Mackinac Tribe. On April 19<sup>th</sup> 2004 attorneys at law Green, Meyer and McElroy gave its legal opinion that Michlimackinac Descendants could make claims (whether or not successful) to the same lands the Sault Tribe & Saginaw Chippewa has claimed, The State of Michigan helped recognize the Sault tribe thru (MOU) agreements aiding in the obstruction of justice misconstruing identity & refusal of recognition of Michilimackinac Tribe descendants whom are enrolled in the Sault Ste Marie tribe. Memorandums of Understandings (MOU) agreements entered into with the Sault Tribe & other Michigan Tribes discriminate service areas and misconstrue Jurisdiction in their entirety, alienating the very people whom seeded Michigan; the state has maintained original Jurisdiction granting Sault tribe very limited resources & guarantees while refusing to recognize its own treaties with the Indians whom made the contracts. Countless letters have been sent to the State of Michigan & Sault Tribe leadership addressing treaty signatory decedents living on the seed & Taxation disputes. No correspondence has ever been received back only phone calls (Michigan) asking if I would like my complaints mailed back to me and a statements of Indians have no rights off their reservation & Mackinac are not federally recognized. Treaties are federally recognized right along with the people that made them! & this complaint is not to be misconstrued! This is a formal inquiry of several United States Treaties by signature whom Michigan is Party furthermore define our aboriginal and federal rights to enforce our signature.

Michigan's MOU agreements with the Sault tribe in which plaintiffs are enrolled do not include any supremacy clauses from 1979, nor identify who the signatory next of kin are that are subject to POWER, Michigan set forth a counterclaim during the land claims United States v Michigan 1979 & its answer in which it asked the court to declare that the Indians involved in this action are not exempt from state regulation. The Court views this counterclaim as a repetition of the denials and defenses, Michigan officials have acted in derogation of the vested aboriginal and federal rights of the plaintiff Indian tribes and protected by the obligations of their guardian, the United States. There are persons within the state whose rights derive from federal (as opposed to state); the state's position on this fundamental concept was stated by its counsel in his opening argument. United States before 1836 exercised dominion over the area which was later to become the State of Michigan, it had not as of that time taken steps to extinguish aboriginal title in the Ottawa's and Chippewa's. The southern portion of the Michigan territory was becoming settled in the early 1800's and there could be no assurance of cloudless title in non-Indian settlers so long as the Indians' aboriginal title to the land remained unextinguished. While the United States had several options available to it in order to accomplish an extinction of Indian title, it chose the most common method of that time and negotiated a treaty of cession with the Ottawa and Chippewa living in the northwestern portion of the lower peninsula and eastern half of the Upper Peninsula of what is now the State of Michigan. Michilimackinac people where driven off their land removed from homes across southern Michigan forced to relocate to swamp Land underneath the great

lakes not livable at all. See. Army core of engineers field notes of southern Michigan, they instructed workers on human remains found are of Michilimackinac Tribe decent, further instructed to continue excavation and impound the remains to the University of Michigan, this happen all over southern Michigan during the building of Michigan's Infistructure. It is proof the Michigan Native Indians were living all over the entire territory See 1795 Maps associated with Treaty of Greenville, Michilimackinac people occupied the entire territory known as the State of Michigan & today and the people that have suffered have been left with nothing! Poverty stricken, taken advantage of & forced to assimilate into Michigan State law. Is it not a travesty of justice when the tenant has jurisdiction over their landlord? Martin v. Hunter's Lessee 1918 {dictum} lessee, leaser.

When a court is called upon to construe an Indian treaty, the Supreme Court has mandated that it employ the following principles which flow from the guardian-ward relationship of the United States to the Indians: The treaty must be construed as the Indians would have understood it; doubtful expressions must be resolved in favor of the Indians, and treaties must be construed liberally in favor of the Indians. Generally, these principles are laid down so that Indian tribes, usually numbering little more than a few thousand, are not wholly disadvantaged by the strength and resources of the United States. In this case every justification ever given in support of these principles is satisfied. Under the United States Constitution, Article VI, clause 2, a treaty made under the authority of the United States becomes the supreme law of the land. Consequently, because a treaty provision maintains the same status as a federal statute, the State cannot regulate what federal law preempts. This is the foundation of plaintiffs' allegation that the State of Michigan may not regulate federally protected rights

A declaratory judgment is properly sought pursuant to 28 U.S.C. § 2201 and § 2202, and this court may grant such relief. Pursuant to 42 U.S. Code § 1981 – constitutionally protected rights. Furthermore Treaties have been signed and injunctive relief can be further granted in part adopt a 42 U.S. Code § 1983 claim.

Venue is properly laid in this court under 28 U.S.C. § 1391(b) in that all plaintiffs reside within the eastern District of Michigan. The Sault Tribe of Chippewa Indians is an entity, with respect to the matters which are party to the subject of this litigation, as only a corporation. Some of its membership is the political successor in interest to the Indians who were party to the Treaty of 1836, Recognized by the United States as a currently functioning Indian tribe maintaining a tribal government. This tribe is organized pursuant to Section 16 of the Indian Reorganization Act, 25 U.S.C. § 476 as a corporation. Its membership is determined in accordance with its Constitution and By-Laws, and the membership criteria require proof that the member is an Indian of the treaty area. (Tr. 1127-29; Ex. P-120.) When the United States negotiated treaties with the Indians of the Territory of Michigan, it was bound by certain responsibilities imposed by previous Treaties and Laws. A treaty can be analogized to a special kind of contract and, like all contracts; the motivations of the parties can, and often do, differ substantially. There were two principal parties to the treaty of the United States and the Indians but each party represented a collection of individual interests. (Tr. 132.) During the treaty making time a power of sale was being circulated amongst the Indians for their signatures (marks) to be affixed. This power of sale (Ex. P-47 and 47A) was sent to Washington and arrived while the treaty negotiations were taking place. (Tr. 143.) Indian delegates came from Muskegon, Grand River, Michilimackinac, L'Arbre Croche and Grand Traverse intervener tribes as the modern tribal successors to the Indians who were signatory to the Treaty of 1836. The Bay Mills Indian Community, The Sault Ste. Marie Tribe of Chippewa Indians, and Michilimacknac Tribe are Indian tribes which enrolled political successors & next of kin in interest to the Indians who were signatory to the Treaty of March 28, 1836 (7 Stat. 491). United States v. John, 437 U.S. 634, 98 S. Ct. 2541, 57 L. Ed. 2d

First, the courts have held that treaties with Indians must be interpreted as the Indians would have understood them. This rule is first set forth in Worcester v. Georgia, 31 U.S. (6 Pet.) 515, 581, 8 L. Ed. 483 (1832) (concurring opinion of Justice McLean) United States v. Shoshone Tribe, 304 U.S. 111, 116, 58 S. Ct. 794, 797, 82 L. Ed. 1213 (1938).



bosom of the great deep there suddenly appeared six beings in human form, who entered their wigwams.

One of these six strangers kept a covering over his eyes, and he dared not look on the An-ish-in-aub-ag, though he showed the greatest anxiety to do so. At last he could no longer restrain his curiosity, and on one occusion he partially lifted his veil, and his eye fell on the form of a human being, who instantly fell dead as if struck by one

of the thunderers. Though the intentions of this dread being were friendly to the An-ish-in-aub-ag, yet the glnnce of his eye was too strong and inflicted certain death. His fellows, therefore, enused him to return into the bosom of the great water from which they had apparently emerged.

The others, who now numbered five, remained with the An-ish-in-aub-ag, and became a blessing to them; from them originate the five great clans or Totems, which are known among the Ojibways by the general terms of A-waus-e, Bus-in-aus-e, Ah-ah-wauk, Noka, and Monsone,

or Waub-ish-ash-e. These are cognomens which are used only in connection with the Totemic system.

Though, according to this tradition, there were but five totems originally, yet, at the present. day, the Ojibway tribe consists of no less than fifteen or twenty families, each claiming a different badge, as follows:-

- 1. Uj-e-jauk, Crane.

- 3. Mong, Loon.
- 4. Muk-wah, Bear.

I have here given a list of every badge that is known as a family totem among the Ojibways throughout their wide-spread villages and bands.

The crane, catfish, bear, marten, wolf, and loon, are the principal families, not only in a civil point of view, but in numbers, as they comprise eight-tenths of the whole tribe. Many of these Totems are not known to the tribe in general, and the writer has learned them only through close inquiry. Among these may be named the goose, beaver, sucker, sturgeon, gull, hawk, cormorant, and white-fish totems. They are only known on the remotest northern boundaries of the Ojibway country, among the Musk-keeg-oes and" Bois Forts."

The old men of the Ojibways whom I have particularly questioned on this subject, affirm that all these different badges are only subdivisions of the five great original totems of the An-ish-in-aub-ag, who bave assumed separate minor badges, without losing sight or remembrance of the main stock or family to which they belong. These divisions have been gradually taking place, caused in the same manner as the division into distinct tribes. They are easily classed under the five great heads, the names of which we have given.

Aish-ke-bug-e-coshe, the old and reliable head chief of the Pillager and Northern Ojibways, has rendered me

much information on this subject. He is the present living recognized head of the great A-waus-e family. He says that this clan claim the Me-ahe-num-aig-way (immense fish) which, according to their description, is equivalent or analogical, to the Leviathan mentioned in the Bible. This being is also one of the Spirits recognized in their grand Me-da--we rite. This clan comprises, the several branches who claim the Catfish, Merman, Sturgeon, Pike, Whitefish, and Sucker Totems, and in fact, all the totems of the fish species may be classed under this general head. This family are physically noted for being long lived, and for the scantiness and fineness of their hair, especially in old age; if you see an old Indian of this tribe with a bald head, you may be certain that he is an A-waus-e.

Tradition says that many generations ago, all the different clans of the tribe, with the exception of the Ahah-wank, formed a league and made war on the A w-aus-e with the intent to exterminate them. But the A w-aus-e
family proved too strong for their united brethren and prevailed against their efforts, and ever since this event,
they have claimed a certain preeminence over them in the councils of the tribe. They also claim, that of the six
beings who emerged from the great water, and originated the Totems, their progenitor was the first who appeared,
and was leader of the others.

Of nine thousand of the Ojibways who reside within the limits of the United States, about the shores of Lake Superior and the headwaters of the Mississippi, full one thousand belong to the Aw-aus-e family.

The Bus-in-as-see, or Crane family, are also numerous, and form an important element of the Ojibway tribe. They reside mostly on the south shores of Lake Superior and toward the east in the Canadas, though they have representatives scattered in every spot where the Ojibways

have set foot and lighted their fires. The literal meaning of their totemic name is, " Echo-maker," derived from the word Bus-wa-wag, "Echo," and pertaining to the loud, clear, and far reaching cry of the Crane. This clan are noted as possessing naturally a loud, ringing voice, and are the acknowledged orators of the tribe; in former times, when different tribes met in councils, they acted as interpreters of the wishes of their tribe. They claim, with some apparent justice, the chieftainship over the other clans of the Ojibways. The late lamented chief Shin-ga-ba-wos-sin, who resided at Sault Ste. Marie, belonged to this family. In Gov. Lewis Cass's treaty at Prairie du Chien in 1825, he was the acknowledged head chief of his tribe, and signed his name to that treaty as such. Ah-mous (the Little Bee), the son of the late worthy chief of Lac du Flambeau, Waub-ish-gaug-aug-e (or White Crow), may now be considered as head or principal chief of this family.

The old war chief Ba-be-eig-aun-dib-ay (Curly Head), whose name is linked with the history of his tribe, and who died on his way returning home from the Treaty of Prairie du Chien above mentioned, was also a Bus-in-aUB-e, and the only representative of his clan amongst that section of his tribe, who so long bravely struggled with the fierce Dakotas for the mastery of the western banks of the Mississippi, which now form the home of the Winne-bagoes. He was the civil and war chief of the Mississippi Ojibways. Hole-in-the-day 1st, of later notoriety, and his brother Song-uk-um-ig (Strong ground), inherited his chieftainship by his dying request, as he died childless. Weesh-e-da-mo, son of Aissance (Little Clam) late British Ojibway chief of Red River, is also a member of this family. He is a young man, but has already received two American medals, one from the hands of a colonel of our army, and the other from the hands of the Governor of Minnesota

Territory. He is recognized by our government as chief of the Pembina. section of the Ojibway tribe. These facts are stated to show the importance of this family, and its wide extended influence over the tribe. It can be said of them that wherever they have planted their wigwam on the widespread territory of their people, they have been recognized as chieftains.

They also boast the names of Keesh-ke-mun, chie(of the Lac du Flambeau section; Che-suh-yauh and Waub-ij-e-jauk (White Crane), of La Pointe, Shaug-a-waum-ik..ong, all noted chiefs during their first intercourse with the

white race.

The small clans who use the eagle as their Totem or . badge, are a branch of the Bua-in-aus-e.

The Ah-ah-wauk, or loon totem, also form an important body in the Ojibway tribe; in fact, they also claim to be the chief or royal family, and one of their arguments to prove this position is that nature has placed a color [collar?] around the neck of the loon, which resembles the royal megis, or wampum, about the neck of a chief, which forms the badge of his honor. This dignity, however, is denied by the Cranes and other totems, who aver that the principal chiefs of the Ah-ah-wauk are descended from individuals who were on a certain occasion made chiefs by the French at Quebec, as will be related in the course of the following history. This family do not lack in chiefs who have acted a prominent part in the affairs of the tribe, and whose names are linked with its history. Ke-che-waish-keenh (Great Buffalo), the respected and venerable chief of the La Pointe band, and principal chief of all the Lake Superior and Wisconsin bands, is the acknowledged head of this clan, and his importance as an individual in the tribe, strengthens the position of the Ah-ah-wauk. The chief of Sandy Lake on the upper Mississippi is also of this family. The Goose and Cormorant

The meeting of American millionaires. --- In the midst of an American population, our own occupy the place of greatest importance. --- Mr abbot Napoléon Labrosse is the curate of catholic parish and Mr Bénoni Lachance is county judge.

Mr abbot NAPOLEAN LABROSSE, curate of the parish of Ste-Anne-de-Mackinac.

The island Mackinac - What is, in the United States, the fortune that favours those who do not know this [êden] in the State of Michigan! This privileged land of nature is gracefully situated aside Lake Huron, at the mouth of Lake Michigan!

There are also the straights of Mackinac where in United States territory Lake Michigan empties its waters into Lake Huron.

The island of Mackinac measures nine miles in circumference and forms an oval. The population, in winter, is about 800 to 900 persons, about 500 to 600 catholics. In summer the population varies between 15 000 and 25 000 persons. It is the gay playground of millionaires from Chicago, Detroit etc.

This island is a park belong to the State. It is considered an excellent place of rest.

There is no industry, no carts, no cars. The boat does not blow its whistle on arrival or departure...there are no [inns and carriages].

The bank of Mackinac at Saint-Ignace is seven miles. Fish are abundant among the lesser islands. There is plenty of muskie, sturgeon, pike etc. Hunting is prohibited. Therefore there are deer, ducks and geese.

There are only two farmers, and they are catholics. The one leases his fields for games, such as golf. The other grows vegetables. The population is supplied from Chicago. The cost of living is excessively expensive.

The population of the island is in large part American. But since the beginning of settlement, the population has been French and Canadian. One of our own, Mr Bénoni Lachance, is county judge. He was also mayor of the town.

Mr Eugène Lachance is warden. This is not a place to be surprised by a basic French populace, since the parish was founded by the Reverend Claude Allouez, in 1669, then the second missionary the Rev Father Marquette.

There are certain persons who still speak French. The pastor is actually a French-Canadian, an energetic young man...

This Mr abbot Napoléon Labrosse, was born at Saint-Hermas, son of Mr Jean-Baptiste LaBrosse and of Miss Lalande daughter of Mr Cyrille Lalande, of Saint-Placide. The curate of Mackinac provided education in his parish of birth and at the Normal school Jacques-Cartier. He was ordained as a priest at Marquette, Mich., 26 July 1903. Vicar of Negaunes, Ishkeming and of Hancock, he was named curate of Mackinac the first of November 1904.

He has the confidence and estime of his flock. He honours our own in the United States. He is valiantly assisted by our distinguished compatriots, Mr judge Lachance and others.

The document translated from folder no. 59 (Ainsse Papers) describes a dispute between interpreter AINSE and a woman CHABOINON. Such a dispute does not discount the possibility that this Sally and Louis Joseph AINSE may have been husband and wife.

Seeking more information concerning Sally, I searched the Parchemin database of notarial records (1635-1779). I have not yet found references to Sally in this database.

I did, however, encounter references to Penash(e). Alongside other chiefs, Penash signed the following legal documents:

06 July 1776, deposit of a donation of a tract of land known by the names of Grosse Isle situated at the mouth of the Detroit River, by the Potawatomi, chiefs and principal leaders of the nation, to William Macomb, merchant, of Detroit, and Alexander Macomb, merchant, of Detroit;

28 July 1780, deposit of a donation of a tract of land situated in the Grand River of Detroit, by the Potawatami, chiefs of the nation, to Jean-Baptiste Reaume;

03 September 1780, deposit of a tract of land situated on the bank of Lake Erie, beginning at a Surau River, by the Potawatomi, chiefs and principal leaders of the nation, to Thomas Fincheley, merchant, of Detroit [Thomas Fincheley is likely that same individual who was witness to the AINSE-Sally discharge.];

22 June 1790, deposit of a sale of a tract of land beginning at the mouth of Catfish Creek, commonly called river au Chaudiere, on the north side of Lake Erie by the Chippewa, war chiefs and principal villagers, Ottawa, war chiefs and principal villagers, Potawatomi, war chiefs and principal villagers, and Huron, war chiefs and principal villagers, to George III, king of Great Britain, France and Ireland.

While seeking other references to Sally or Penashe, I encountered the following references.

According to the "Wisconsin Historical Collections" volume 18, page 489, the witnesses to the 1775 marriage of Joseph Ainsse and Therese Bondy included "on behalf of the husband: of Louis Cardin, his brother; of Marie Anne Cardin, his sister; of francois Maurice de la fantaisie, his Brother-in-law; of Sieur Montforton, notary, his friend; of Sieur Guillaume La Motte, also his friend; and, on behalf of his wife: of Sieur jean Baptiste Bondy, her brother, and of Benjamin Papin, her friend..."

According to the "Wisconsin Historical Collections" volume 19, page 26, "March 22, 1749, I baptized conditionally an illegitimate child born of Constante Chevalier, widow of the late hins and of father whom she would not name. The child was privately baptized through fear of accident. The godfather was Antoine janis who gave him his name and signed here with me; and the godmother was esther Chevalier...

The father of the child is Mr. dequindre, according to the declaration of the lady..."

According to the "Wisconsin Historical Collections" volume 19, pages 30 and 31, "February 11, 1751, I baptized in the church of this mission Marie Angelique, natural daughter of Constance Chevalier, widow hins, born this month, whose father she did not declare. The godfather was Etienne Chenier; and the godmother the wife of Sieur Alexis Sejourné dit Sans Chagrin, Sergeant of the troops...

The godfather was Mr. janis; and the godmother Mll. Chaboiller. M. L. LEFRANC, Miss. of the society of Jesus.

According to the "Wisconsin Historical Collections" volume 19, pages 77 and 78, "In 1776, Marianne Cardin, wife of fransoi morisse Le fantasie, gave birth to a boy on the 15th of March. He was privately baptized by his uncle, Joseph Ainsse, at six o'clock in the evening.

In the year 1778, marianne Cardin, wife of françois Morise dit La fantizie, gave birth to a boy on June 18. He was privately baptized by his uncle, Joseph Ainsse."

Concerning references to Sally and/or Penashe, I have examined all records in all 162 folders of the AINSSE Papers. In addition to those documents cited in previous correspondence, I found only the following document which may relate to Penashe.

The following document may or may not refer to Penashe. This document seems out of place with the other records in the Ainsse papers.

In my research concerning Sally AINSE, I examined an article by Tom Brisco "Sallee Ainse (Oneida), 1728-1823: An Aboriginal Woman in the Fur Trade" published in Louise Johnston's "Aboriginal People and The Fur Trade: Proceedings of the 8th North American Fur Trade Conference, Akwesasne" (2000). The article contains no mention of Joseph AINSE. Nevertheless, I would be please to copy this article if necessary.

In the "Dictionary of Canadian Biography" (volume 6), John Clarke has published an article concerning Sarah AINSE (Hands) (MONTOUR; MAXWELL; WILLSON). "Her exact name is not known but there is speculation that it may have been Hance, a name common among the Six Nations...At 17 she became the second wife of Andrew (Henry) Montour...In 1755 or 1756 the family was split...she had expanded her activities westward to the north shore of Lake Erie and it seems she was trading to Michilimackinac (Mackinaw City, Mich.) by 1767. Because of the similarity of names it has often been thought that she was married to Joseph-Louis Ainsse, the

Michilimackinac interpreter, but it appears that when she was there she lived, for a while at least, with trader William Maxwell. " (pp 7-8)

I encourage you to borrow on interlibrary loan through your local library Frederick Coyne Hamil's "Sally Ainse: Fur Trader" (Detroit: Algonquin Club, 1939). That text may have more to say about Joseph AINSE. If you are unable to gain access to this text, I will attempt to do so.



bosom of the great deep there suddenly appeared six beings in human form, who entered their wigwams.

One of these six strangers kept a covering over his eyes, and he dared not look on the An-ish-in-aub-ag, though he showed the greatest anxiety to do so. At last he could no longer restrain his curiosity, and on one occusion he partially lifted his veil, and his eye fell on the form of a human being, who instantly fell dead as if struck by one of the thunderers. Though the intentions of this dread being were friendly to the An-ish-in-aub-ag, yet the glnnce of his eye was too strong and inflicted certain death. His fellows, therefore, enused him to return into the bosom of the great water from which they had apparently emerged.

The others, who now numbered five, remained with the An-ish-in-aub-ag, and became a blessing to them; from them originate the five great clans or Totems, which are known among the Ojibways by the general terms of A-waus-e, Bus-in-aus-e, Ah-ah-wauk, Noka, and Monsone,

or Waub-ish-ash-e. These are cognomens which are used only in connection with the Totemic system.

Though, according to this tradition, there were but five totems originally, yet, at the present. day, the Ojibway tribe consists of no less than fifteen or twenty families, each claiming a different badge, as follows:-

I have here given a list of every badge that is known as a family totem among the Ojibways throughout their wide-spread villages and bands.

The crane, catfish, bear, marten, wolf, and loon, are the principal families, not only in a civil point of view, but in numbers, as they comprise eight-tenths of the whole tribe. Many of these Totems are not known to the tribe in general, and the writer has learned them only through close inquiry. Among these may be named the goose, beaver, sucker, sturgeon, gull, hawk, cormorant, and white-fish totems. They are only known on the remotest northern boundaries of the Ojibway country, among the Musk-keeg-oes and" Bois Forts."

The old men of the Ojibways whom I have particularly questioned on this subject, affirm that all these different badges are only subdivisions of the five great original totems of the An-ish-in-aub-ag, who bave assumed separate minor badges, without losing sight or remembrance of the main stock or family to which they belong. These divisions have been gradually taking place, caused in the same manner as the division into distinct tribes. They are easily classed under the five great heads, the names of which we have given.

Aish-ke-bug-e-coshe, the old and reliable head chief of the Pillager and Northern Ojibways, has rendered me

much information on this subject. He is the present living recognized head of the great A-waus-e family. He says that this clan claim the Me-ahe-num-aig-way (immense fish) which, according to their description, is equivalent or analogical, to the Leviathan mentioned in the Bible. This being is also one of the Spirits recognized in their grand Me-da-we rite. This clan comprises, the several branches who claim the Catfish, Merman, Sturgeon, Pike, Whitefish, and Sucker Totems, and in fact, all the totems of the fish species may be classed under this general head. This family are physically noted for being long lived, and for the scantiness and fineness of their hair, especially in old age; if you see an old Indian of this tribe with a bald head, you may be certain that he is an A-waus-e.

Tradition says that many generations ago, all the different clans of the tribe, with the exception of the Ahah-wank, formed a league and made war on the A w-aus-e with the intent to exterminate them. But the A w-aus-e family proved too strong for their united brethren and prevailed against their efforts, and ever since this event, they have claimed a certain preeminence over them in the councils of the tribe. They also claim, that of the six beings who emerged from the great water, and originated the Totems, their progenitor was the first who appeared, and was leader of the others.

Of nine thousand of the Ojibways who reside within the limits of the United States, about the shores of Lake Superior and the headwaters of the Mississippi, full one thousand belong to the Aw-aus-e family.

The Bus-in-as-see, or Crane family, are also numerous, and form an important element of the Ojibway tribe. They reside mostly on the south shores of Lake Superior and toward the east in the Canadas, though they have representatives scattered in every spot where the Ojibways

have set foot and lighted their fires. The literal meaning of their totemic name is, " Echo-maker," derived from the word Bus-wa-wag, "Echo," and pertaining to the loud, clear, and far reaching cry of the Crane. This clan are noted as possessing naturally a loud, ringing voice, and are the acknowledged orators of the tribe; in former times, when different tribes met in councils, they acted as interpreters of the wishes of their tribe. They claim, with some apparent justice, the chieftainship over the other clans of the Ojibways. The late lamented chief Shin-ga-ba-wos-sin, who resided at Sault Ste. Marie, belonged to this family. In Gov. Lewis Cass's treaty at Prairie du Chien in 1825, he was the acknowledged head chief of his tribe, and signed his name to that treaty as such. Ah-mous (the Little Bee), the son of the late worthy chief of Lac du Flambeau, Waub-ish-gaug-aug-e (or White Crow), may now be considered as head or principal chief of this family.

The old war chief Ba-be-eig-aun-dib-ay (Curly Head), whose name is linked with the history of his tribe, and who died on his way returning home from the Treaty of Prairie du Chien above mentioned, was also a Bus-in-aUB-e, and the only representative of his clan amongst that section of his tribe, who so long bravely struggled with the fierce Dakotas for the mastery of the western banks of the Mississippi, which now form the home of the Winne-bagoes. He was the civil and war chief of the Mississippi Ojibways. Hole-in-the-day 1st, of later notoriety, and his brother Song-uk-um-ig (Strong ground), inherited his chieftainship by his dying request, as he died childless. Weesh-e-da-mo, son of Aissance (Little Clam) late British Ojibway chief of Red River, is also a member of this family. He is a young man, but has already received two American medals, one from the hands of a colonel of our army, and the other from the hands of the Governor of Minnesota

Territory. He is recognized by our government as chief of the Pembina. section of the Ojibway tribe.

These facts are stated to show the importance of this family, and its wide extended influence over the tribe. It can be said of them that wherever they have planted their wigwam on the widespread territory of their people, they have been recognized as chieftains.

They also boast the names of Keesh-ke-mun, chie(of the Lac du Flambeau section; Che-suh-yauh and Waub-ij-e-jauk (White Crane), of La Pointe, Shaug-a-waum-ik..ong, all noted chiefs during their first intercourse with the white race.

The small clans who use the eagle as their Totem or . badge, are a branch of the Bua-in-aus-e.

The Ah-ah-wauk, or loon totem, also form an important body in the Ojibway tribe; in fact, they also claim to be the chief or royal family, and one of their arguments to prove this position is that nature has placed a color [collar?] around the neck of the loon, which resembles the royal megis, or wampum, about the neck of a chief, which forms the badge of his honor. This dignity, however, is denied by the Cranes and other totems, who aver that the principal chiefs of the Ah-ah-wauk are descended from individuals who were on a certain occasion made chiefs by the French at Quebec, as will be related in the course of the following history. This family do not lack in chiefs who have acted a prominent part in the affairs of the tribe, and whose names are linked with its history.

Ke-che-waish-keenh (Great Buffalo), the respected and venerable chief of the La Pointe band, and principal chief of all the Lake Superior and Wisconsin bands, is the acknowledged head of this clan, and his importance as an individual in the tribe, strengthens the position of the Ah-ah-wauk. The chief of Sandy Lake on the upper Mississippi is also of this family. The Goose and Cormorant

The Island of Mackinac, Michigan

The meeting of American millionaires. --- In the midst of an American population, our own occupy the place of greatest importance. --- Mr abbot Napoléon Labrosse is the curate of catholic parish and Mr Bénoni Lachance is county judge.

Mr abbot NAPOLEAN LABROSSE, curate of the parish of Ste-Anne-de-Mackinac.

The island Mackinac - What is, in the United States, the fortune that favours those who do not know this [êden] in the State of Michigan! This privileged land of nature is gracefully situated aside Lake Huron, at the mouth of Lake Michigan!

There are also the straights of Mackinac where in United States territory Lake Michigan empties its waters into Lake Huron.

The island of Mackinac measures nine miles in circumference and forms an oval. The population, in winter, is

about 800 to 900 persons, about 500 to 600 catholics. In summer the population varies between 15 000 and 25 000 persons. It is the gay playground of millionaires from Chicago, Detroit etc.

This island is a park belong to the State. It is considered an excellent place of rest.

There is no industry, no carts, no cars. The boat does not blow its whistle on arrival or departure...there are no [inns and carriages].

The bank of Mackinac at Saint-Ignace is seven miles. Fish are abundant among the lesser islands. There is plenty of muskie, sturgeon, pike etc. Hunting is prohibited. Therefore there are deer, ducks and geese.

There are only two farmers, and they are catholics. The one leases his fields for games, such as golf. The other grows vegetables. The population is supplied from Chicago. The cost of living is excessively expensive.

The population of the island is in large part American. But since the beginning of settlement, the population has been French and Canadian. One of our own, Mr Bénoni Lachance, is county judge. He was also mayor of the town

Mr Eugène Lachance is warden. This is not a place to be surprised by a basic French populace, since the parish was founded by the Reverend Claude Allouez, in 1669, then the second missionary the Rev Father Marquette.

There are certain persons who still speak French. The pastor is actually a French-Canadian, an energetic young man...

This Mr abbot Napoléon Labrosse, was born at Saint-Hermas, son of Mr Jean-Baptiste LaBrosse and of Miss Lalande daughter of Mr Cyrille Lalande, of Saint-Placide. The curate of Mackinac provided education in his parish of birth and at the Normal school Jacques-Cartier. He was ordained as a priest at Marquette, Mich., 26 July 1903. Vicar of Negaunes, Ishkeming and of Hancock, he was named curate of Mackinac the first of November 1904.

He has the confidence and estime of his flock. He honours our own in the United States. He is valiantly assisted by our distinguished compatriots, Mr judge Lachance and others.

Bondy, Thos Baron, Ls Plessis Bellair and the third September...before us Jean Marie Mondelet, who has voluntarily accepted said charge of surrogate guardian of said minors, and has taken the oath of office and has signed

Thank you for the \$350 payment.

The document translated from folder no. 59 (Ainsse Papers) describes a dispute between interpreter AINSE and a woman CHABOINON. Such a dispute does not discount the possibility that this Sally and Louis Joseph AINSE may have been husband and wife.

Seeking more information concerning Sally, I searched the Parchemin database of notarial records (1635-1779). I have not yet found references to Sally in this database.

I did, however, encounter references to Penash(e). Alongside other chiefs, Penash signed the following legal documents:

06 July 1776, deposit of a donation of a tract of land known by the names of Grosse Isle situated at the mouth of the Detroit River, by the Potawatomi, chiefs and principal leaders of the nation, to William Macomb, merchant, of Detroit, and Alexander Macomb, merchant, of Detroit;

28 July 1780, deposit of a donation of a tract of land situated in the Grand River of Detroit, by the Potawatami,

chiefs of the nation, to Jean-Baptiste Reaume;

03 September 1780, deposit of a tract of land situated on the bank of Lake Erie, beginning at a Surau River, by the Potawatomi, chiefs and principal leaders of the nation, to Thomas Fincheley, merchant, of Detroit [Thomas Fincheley is likely that same individual who was witness to the AINSE-Sally discharge.];

22 June 1790, deposit of a sale of a tract of land beginning at the mouth of Catfish Creek, commonly called river au Chaudiere, on the north side of Lake Erie by the Chippewa, war chiefs and principal villagers, Ottawa, war chiefs and principal villagers, Potawatomi, war chiefs and principal villagers, and Huron, war chiefs and principal villagers, to George III, king of Great Britain, France and Ireland.

While seeking other references to Sally or Penashe, I encountered the following references.

According to the "Wisconsin Historical Collections" volume 18, page 489, the witnesses to the 1775 marriage of Joseph Ainsse and Therese Bondy included "on behalf of the husband: of Louis Cardin, his brother; of Marie Anne Cardin, his sister; of francois Maurice de la fantaisie, his Brother-in-law; of Sieur Montforton, notary, his friend; of Sieur Guillaume La Motte, also his friend; and, on behalf of his wife: of Sieur jean Baptiste Bondy, her brother, and of Benjamin Papin, her friend..."

According to the "Wisconsin Historical Collections" volume 19, page 26, "March 22, 1749, I baptized conditionally an illegitimate child born of Constante Chevalier, widow of the late hins and of father whom she would not name. The child was privately baptized through fear of accident. The godfather was Antoine janis who gave him his name and signed here with me; and the godmother was esther Chevalier...

The father of the child is Mr. dequindre, according to the declaration of the lady..."

According to the "Wisconsin Historical Collections" volume 19, pages 30 and 31, "February 11, 1751, I baptized in the church of this mission Marie Angelique, natural daughter of Constance Chevalier, widow hins, born this month, whose father she did not declare. Concerning references to Sally and/or Penashe, I have examined all records in all 162 folders of the AINSSE Papers. In addition to those documents cited in previous correspondence, I found only the following document which may relate to Penashe.

In my research concerning Sally AINSE, I examined an article by Tom Brisco "Sallee Ainse (Oneida), 1728-1823: An Aboriginal Woman in the Fur Trade" published in Louise Johnston's "Aboriginal People and The Fur

Trade: Proceedings of the 8th North American Fur Trade Conference, Akwesasne" (2000). The article contains no mention of Joseph AINSE. Nevertheless, I would be please to copy this article if necessary.

In the "Dictionary of Canadian Biography" (volume 6), John Clarke has published an article concerning Sarah AINSE (Hands) (MONTOUR; MAXWELL; WILLSON). "Her exact name is not known but there is speculation that it may have been Hance, a name common among the Six Nations...At 17 she became the second wife of Andrew (Henry) Montour...In 1755 or 1756 the family was split...she had expanded her activities westward to the north shore of Lake Erie and it seems she was trading to Michilimackinac (Mackinaw City, Mich.) by 1767. Because of the similarity of names it has often been thought that she was married to Joseph-Louis Ainsse, the Michilimackinac interpreter, but it appears that when she was there she lived, for a while at least, with trader William Maxwell." (pp 7-8)

I encourage you to borrow on interlibrary loan through your local library Frederick Coyne Hamil's "Sally Ainse: Fur Trader" (Detroit: Algonquin Club, 1939). That text may have more to say about Joseph AINSE. If you are unable to gain access to this text, I will attempt to do so.
