He has also been involved with the Tribal Law and Policy Institute since 2014. He is a licensed clinical therapist in Wisconsin and Michigan and currently serves as a project director for [Justice for Vets](#), and the Tribal division of [NADCP](#).



Katharine (Katie) Stewart, *National Coordinator, Veterans Justice Outreach (VJO), U.S. Department of Veterans Affairs*. Katie contributes to the development of national policy, provide guidance to the field on operational matters, and represents the VJO program with internal and external audiences.
