23	assistance with its inmate housing needs and S	heriff Balaam agreed to help
24	that federal agency.	
25	But that is where Sheriff Balaam's role in th	nis case ends. The Washoe
26	Tribe of Nevada and California is a distinct and	separate sovereign. Sheriff

1	Balaam has no role or oversight in that government's court system so his
2	Office only has limited information related to each of Petitioner's cases.
3	Consequently, the Washoe Tribe needs to come forward to explain for itself
4	the legality of the Petitioners' detention to this Court. Sheriff Balaam will
5	then accept any decision made this Court with respect to the custody of each
6	of the Petitioners.
7	Finally, no Petitioner alleges mistreatment while being housed at the
8	Washoe County Detention Facility, so each inmate's immediate personal
9	well-being is not at issue. But Sheriff Balaam has no objection to this Court
10	transferring any Petitioner to an appropriate federal facility while this federal
11	matter is pending.
