I reported very serious crimes to United States Prosecutor Ted Mc Bride of Rapid City, SD. in 1999. (See Docs) Earlier I contacted The United States Attorney General, Janet Reno, appointed a year before. She fowarded my letter/Complaint to G. Allen Carver Jr. o of F.B.I. Fraud section, Washinhton, D.C. Director Craver responded Oct. 4, 1994, (By Donald Foster). We instructed me to contact local Federal authorities with any information/evidence that I may have if warranted, They can conduct an investigation. That's the reason I contacted U.S. Attorney Ted Mc Bride of Rapid City, SD with info that I felt "Warranted a Federal Investigation". Episcopal church attorney Robert J. Maule (deceased) stated that he "Knew", that I contacted"A U.S. atty", in his answer to the South Dakota state Bar, in answering my complaint against him. (Docs available). The only U.S. atty that I contacted was Ted Mc Bride of Rapid City, SD How Church atty Robert Maule knew this is unknown to me. Robert Maule in his 2000 responce gives a lot of information to the S.D. There was NO response from him.(In 2000 while answering my complaint against Church attorney Robert Maule, He wrote that he knew that I contacted the U.S. attorney in my investigation of them.).Robert Maule may have had contact with Mr. Mc Bride, which of course is illegal and unethical, as well as criminal. We now know that Church atty.Robert Maule and Judge of Winner, SD Max Gors stole millions of dollars of our money(May 1991). The stolen TRUSTS were found on Aug.16,2019 by Miriam Montileaux at the First National Bank in Sioux Falls, South Dakota, Under Chapter of Calvary Cathedral.
