First we object to attorney Ashley Brost serving as attorney, and/ or ask for the Judges to take note that she after law school cler-ked for Hon. Roger L. Wollman of United States Court of Appeals for the 8th Circuit". also we note that Atty Ashley Brost was "Cri-minal Justice Act defense attorney for the United States Dist. Court for Dist.of South Dakota AND the United States Court of APPEALS for the 8th Circuit". Attorney Ashley is very well connected. And according to best selling lawyer and author Mark H. Mc-Cormack on page 95. of book" TERRIBLE TRUTH ABOUT LAWYERS", he states "Keep in mind, too, that top-ticket lawyers are charging you not just for what they know but who they know".

Robert Maule f filed under 2 counties, Todd AND Tripp. 2 counties under one roof, The WINNER COURT HOUSE IN WINNER, SD. Atty. My Counselor, ED Hankla, who was MURDERED BY THE CROOKS: Stated to me that I was very Vuln erable as my wife died and 2 weeks later they had me signing pape rs in Winner, SD. One of the DEFENDANTS Randy Reinartz was there in Winner, SD and participated in criminal activity (See copies of documents that he signed, with out my knowledge and/or consent, one day after Atty. Robert Maule deceived me into signing (See copies of documents enclosed). Many of the criminal activity was reporte the briefs and supporting documents that were either DISMI SSED and/or rendered by Judge Karen Schrier on Feb.24,2021.(We fe -el that there should have been a CRIMINAL INVESTIGATION BY US AT TY. FOR SD RONALD PARSONS, AS THIS WAS REPORTED TO HIM. AUG. 2021 0 letter.

Mr. Tim La Pointe wrote to us and referred us to Mr. John L Long, BIA Superintendent at Pine Ridge Agency, on Pine Ridge Indian Reservation.. Mr. John Long did not answer us. He choose to "Reti re", with out answering our letter. Thus our letter and documents sent to him sat for about 2 months or more. I had to call the BIA Office in Pine Ridge, So. Dak. and was informed that John Long "Ret ired". I spoke with Kristy Orourke, who later wrote to me(see lett er-copy), she stated that she consulted with officials in Aberdeen , So. Dak. and they basically cant help us. On May 12,2021 I wrote to the newly appointed Secretary of The Interior Honorable Deb Haaland(Attorney credentials) and sent her the info(A packet) The previous Secretary of The Interior Mr. Bernherdt did not know wha t to do, Thus sent all documents to Mr. Tim LaPointe in Aberdeen, S

It is apparent the 2 female attorneys who were brought in very la te in the case are grasping for straws in their feeble legal argu -ments. We feel that iy is a conflict of interest for atty. Ashle y Brost to represent the Bank defendants ,as she knew and clerked for Honorable Judge Woolman of the 8th Circuit Court of Appeals. Is is also very crucial that the 8th Circuit Judges know that it was NOT ONLY CHERYL MONTILEAUX that was suing the Hospital and 4 Doctors in Chicago, ILL. We, (me and minor kids were also suing the m.) The minor kifs should have been appointed Guardian ad Litems by the Chicago, ILL Federal Court, (By our atty. Valerie A. Leopold and Federal Judge Harry D. Leinenweber. They did not, or if they di d, they did not let us know.) And I, Judge Charles T. Montileaux, was also suing them as well. (It was part of supporting do -cument, MOTION TO PROTECT MIRIAM MONTILEAUX FROM STATE OF SO. DAK OFFICIALS.). Denny K. was Secretary of corrections under Gov. Dennis Daaugard(and was very close friends with crooked state jud ge MAX GORS. Moreover, former US atty for Dist. of South Dakota Randy Seilor was a prosecutor or states atty for Hughes County wh ere much criminal activity took place. While were on the subject of Hughes County another supporting document dismissed by Judge Karen Schrier documents that Hughes County Prosecutor ROXANNE HAMMOND and Pierre, SD Detective were to have gone over the findin gs of Detective Pelle concerning the investigation and findings of his evidence, AND let me know what they decide. It has been our experience as Native American Indians here in So. Dak. that when a non-white person is accused of a crime the FEDERAL AND STATE AUTHORITIES TAKE VERY AGRESSIVE ACTION even to the point of invading the reservation with helicopters and armed federal agents to arrest Native Indian. But when criminals like the "Mafia-like" criminals are reported there is no investigation(Ron A. Parsons, US ATTY). "Toxic white Privilege" has to be addressed and stopped by 8th court of Appeal

Terry Pechota (mentioned in my complaint against Judge Jeffrey L. Viken to 8th Circuit). Tom Tobin States atty. for T Tripp County. Judge Marvin Talbott (Who I mention as the ex-FBI agent turned Circuit Judge (Granted crook Atty Robert Maule ILLEGAL papers concerning estate of Cheryl Montileaux.)

Mr Levis question to Mr. Tobin " 1977 Supreme Court ruled that re servation deminished to Todd County "Little Thunder Decision". Mr. Tobin answers " Well as Mr. Pechota states, Todd County is att ached to to Tripp County for that particular function, BECAUSE TOD D COUNTY IS AN INDIAN RESERVATION, THE STATES JURISDICTION IS LIMI TED BY COURT DECISIONS AND FEDERAL STATUTES IN TODD COUNTY".

Also in the same vain ,Judge Karen Schrier in December 13,2002 article by Senior staff write Dottie Potter of "Lakota Journal" newspaper. She presided in a court hearing concerning jurisdictio n when the Episcopal Diocese of SD file a motion for temp. Rest. Order and permanent Injunction against Oglala Sioux Tribal Court Judge Sidney and tribal member Judge Charles T. Montileaux who fi led a lawsuit in August against the EPISCOPAL DIOCESE OF SOUTH DA KOTA.. The "Federal Court ruled in favor of the OST Court, Judge W Witt, and MONTILEAUX by stating in part that " the public interest is best served by allowing the OST court the opportunity to decid e whether or not it has jurisdiction. Therefore, this court will stay this action pending exhaustion of the jurisdictional issue i in the tribal court system". According to OST General Counsel, Ma rio Gonzalez, that ruling was a victory for the tribal court and MONTILEAUX." In summary, the crooks and church atty. Robert Maule did commit crimes ON AN INDIAN RESERVATION(TODD COUNTY) AGAINST A AN INDIAN(ME AND FAMILY) BY STEALING OUR TRUSTS USING BOTH TRIPP AND TODD COUNTY ON COURT DOCUMENTS (SEE ENCLOSED). THUS TREATY AND STATE AND FEDERAL LAWS WERE VIOLATED BY NAMED MAFIA LIKE CRIMINAL S.

- 2.0 That all of the named defendants be prosecuted for, but not limmited to; Murder, fraud, bank and Insurance fraud etc.
- 3.) That our trust Funds be returned to us with all interest that accumulated, and all documents that go with this. AND 40 million dollars to be paid to us by th First National Bank in Sioux Falls, South Dakota.
- 4.) That the Episcopal Diocese of South Dakota (and Chapter of calvary cathedral and mentioned individuals be ordered to pay us 40 million dollars. And that they be prosecuted for Murder and other crimes mentioned previously.
- 5.) To determine if Judge Karen Schrier had a conflict of Interes in hearing and dismissing our lawsuit. As she previously heard a case with the same episcopal criminals against us. (2002 Dottie Potter article.
- 6.) That the Episcopal Bishop, Jonathan, in addition to paying us 4 40 million dollars, issue an public apology for the serious crimes committed against us by his church and people.
- 7.) That the Mafia-like criminals would NOT be allowed to get awa y with such destructive and some would aggue racist motivated cri mes against us, members of the Oglala Sioux Tribe.
- 8.) That the 8th circuit court take judicial notice that we plan to write a TRUE CRIME book in the style of noted author. We plan t to name names as we documented everything.
- 9.) That Plaintiff Miriam Montileauxs incarceration and attempts to kill her AND for keeping her "In the hole" for 2 years be full y investigated. (State of South Dakota officials have been named, including letters to then Governor Dennis Daaugard, and denny K. All of this is fully documented and as stated a true crime book w will be published. (We are considering several options.
