Are you a graduate from a climate science master's degree program or have a related science background? Do you enjoy writing about and sharing your knowledge about climate science? If you are up for the challenge of helping grow a dynamic initiative providing judges the foundation in climate science that they need to keep pace with the climate issues emerging in courtrooms and the law? If so, the [Environmental Law Institute](#) needs you as our Science Fellow, Climate Judiciary Project.

WHAT WOULD YOU BE DOING EXACTLY?

As the Science Fellow, Climate Judiciary Project (CJP), you will work under the direction of the Senior Manager, CJP, and in consultation with the Director of the Judicial Education Program and the Project Leader to develop curriculum materials and analyses on science, law, and policy issue related to the Climate Judiciary Project.

The Institute is known for its pioneering Judicial Education Program, and in particular, the Climate Judiciary Project, which provides the information and training needed to meet judges' need for a basic familiarity with current climate science to keep pace with the climate issues emerging in courtrooms and the law. The project conducts education programs, produces educational materials, and fosters a better understanding of climate science and the law in the judicial community.

As part of the CJP team, your goals will be to:

- Develop a professional education program for judges made up of a series of stand-alone modules on physical climate dynamics, impacts and their disparity among groups, legal trends, and climate solutions that can fit together to create a comprehensive course, and recruit judges to participate in part or all of it;
- Produce slides, pre-recorded lectures, and interactive activities focused on key scientific and legal issues and disseminate them through various educational channels;
- Organize climate talks for select groups of judges in key jurisdictions, and present at judicial conferences and law school events;
- Identify, recruit, and train legal scholars and scientific experts willing to deliver educational offerings to additional judicial audiences using the curricular modules developed for the program;
- Expand the network of judges willing to serve as ambassadors and vouch for the value of this professional development opportunity to their colleagues.
- Your specific responsibilities will include:
 - **Curriculum development.** Provide content research on climate science for curriculum, in support of authors drafting modules.

- **Contributing to program content.** Draft materials for publication, presentation, and other communications materials, on climate science topics, and the intersections of climate science and law and policy.
- **Workshop convening.** Contribute to the preparation and development of presentation materials.
- **Support coordination of network of judicial climate science educators.** As part of the CJP team, contribute to the development and convening of in-person and virtual events.
- **Web management.** Help develop science content for website.
- **Other duties as needed.** Conduct any other duties as assigned by project management, meet deadlines, and respect project budgets, and other project requirements.

WHAT DO YOU NEED TO THRIVE IN THIS ROLE?

ELI is looking for someone with a Master's or equivalent degree in a discipline relating to climate science, although experience can substitute for a post graduate degree. You need to be familiar with climate science, its impacts, and ideally, their relationship to the law. You must have excellent skills in science research and analytical writing. You need to be an effective communicator in a variety of mediums and with a broad range of people, including representing ELI publicly in a manner consistent with our mission and values. The CJP team is collaborative by nature and you must be work directly with people from diverse racial, ethnic, and socioeconomic backgrounds. We employ anti-racist practices and principles while striving to support ELI's culture of diversity, equity, inclusion, and justice. Because swift and efficient action is needed to help address climate change, the ability to conduct effective and efficient research on scientific literature with moderate supervision while producing high quality results on deadline and within budget is essential. You need to be proficient with standard office software including Microsoft Word, Outlook, Excel, and PowerPoint
