APPELLANT'S MOTION TO REMAND FOR AN EVIDENTIARY HEARING

Appellant, through his attorney of record, Nicollette Brandt, moves this Court to remand Appellant's case for an evidentiary hearing on grounds that the State lacks jurisdiction because Appellant was an Indian at the time of the offense and because the offenses occurred in Indian Country.

Pursuant to the federal "Major Crimes Act," Oklahoma has no jurisdiction to prosecute certain crimes, including rape by instrumentation and lewd act with a child under 16, if either the defendant or alleged victim is an "Indian" and the crime occurred in "Indian Country." See 18 U.S.C. § 1153(a) (2013) (any "Indian" who commits "a felony under chapter 109A . . . within the Indian country, shall be . . . within the exclusive jurisdiction of the United States."); 18 U.S.C. § 109A (2013) (enumerates crimes of sexual abuse, including sexual abuse of a minor). See also Cravatt v. State, 1992 OK CR 6, ¶ 16, 825 P.2d 277, 279 ("The State of Oklahoma does not have jurisdiction over crimes committed by or against an Indian in Indian Country.").

Though there was no official determination of Appellant's Indian status

in the district court nor was the information included in the Brief of Appellant filed December 18, 2020, Appellant's family recently provided appellate counsel with proof that he is an Indian under federal law. According to a membership card issued September 6, 2013, Jeffrey Don McClain, born July 24, 1989, is a registered member of the Choctaw Nation. (Exhibit A) A United States Department of the Interior Bureau of Indian Affairs Certificate of Degree of Indian Blood Card issued on November 1, 1991, documents that Appellant is of 5/32-degree of Indian blood of the Choctaw/Creek Tribes. (Exhibit A) Appellate counsel obtained official verification from the Choctaw Nation of Oklahoma, CDIB & Tribal Membership Department, that Appellant holds an assigned Choctaw Nation Number (CN153069) and a Certified Degree of Indian Blood (CDIB). (Exhibit B) As such, Appellant submits that he is recognized as an Indian by the federal government.

Title 18, Section 1151, Subsection (a) of the United States Code defines "Indian Country" as:

all land within the limits of any Indian reservation under the jurisdiction of the United States Government, notwithstanding the issuance of any patent, and including rights-of-way running through the reservation, (b) all dependent Indian communities within the borders of the United States whether within the original or subsequently acquired territory thereof, and whether within or without the limits of a state, and (c) all Indian allotments, the Indian titles to which have not been extinguished, including rights-of-way running through the same.

18 U.S.C. § 1151 (1949).

The alleged acts charged against Appellant occurred in McCurtain

County, Oklahoma. McCurtain County clearly falls within the recognized boundaries of the Choctaw Nation. *See* Choctaw Const., art. I., § 2; Map of the Choctaw Nation Service Area obtained from the Oklahoma Department of Transportation - produced map of Tribal Jurisdictions in Oklahoma, found at https://www.ok.gov/health2/documents/map_tribal_jurisdictions.pdf (last visited May 18, 2021). (Exhibit C)

Likewise, the Choctaws' subsequent use of their land and demographics of the Choctaw Nation are submitted as illustrated in the Maps of the Choctaw Service Area and Tourism Destinations, that further establish how the Choctaw Nation continues to flourish and provide services, assistance, education, preservation and cultural enrichment within the Nations' long-established borders. See https://www.choctawnation.com/sites/default/files/2015/09/29/tourismlocations_or iginal.pdf (last visited May 18, 2021). The submitted materials individually, and/or in combination, weigh heavily in favor of finding the Choctaw Nation jurisdictional boundaries remain intact.

Congress has taken no action to disestablish the Choctaw "reservation." As a result, the boundaries of the Choctaw Nation remain intact. See Murphy, 875 F.3d 896, 966 (finding Creek Nation's historical boundaries still intact and thus still maintains its status as 5 "Indian Country"); Nebraska v. Parker, 136 S.Ct. 1072, 1076-1082, 194 L.Ed.2d 152 (2016); Solem v. Bartlett, 465 U.S. 463, 481, 104 S.Ct.1161, 1171, 79 L.Ed.2d 443 (1984).

Both the United States Supreme Court and this Court have recently recognized that federal and tribal governments, not the State of Oklahoma, have exclusive jurisdiction to prosecute crimes committed by or against Indians on reservations. *Bosse v. State*, 2021 OK CR 3, ¶ 3, _ P.3d _ (citing *McGirt v. Oklahoma*, 140 S.Ct. 2452 (2020)). In *McGirt*, the Supreme Court held that Congress had not disestablished the Muscogee Creek Reservation, and thus only the federal and tribal governments hold jurisdiction to prosecute crimes committed by or against Indians within the Muscogee Creek Reservation. *Bosse*, 2021 OK CR 3, ¶ 3, _ P.3d _ (citing *McGirt*, 140 S.Ct. at 2468; 18 U.S.C. §§ 1152, 1153).

In *Bosse*, the Court reversed the defendant's conviction after finding that the victims of the defendant's crime had "some Indian blood" and were recognized as Indian by a tribe or the federal government. *Bosse*, 2021 OK CR 3, ¶ 7, _ P.3d _. The Court also found that the crime occurred within the Chickasaw Nation Reservation, and that Congress had not disestablished the reservation. *Id.*, 2021 OK CR 3, ¶ 8. Based on these findings, the Court reversed the Judgment and Sentence entered against the defendant, and the Court held that since the victims were Indian and the crime was committed within an Indian Reservation, only the federal government had jurisdiction to prosecute the defendant. *Id.*, 2021 OK CR 3, ¶ 29.

Counsel brings this information to the attention of the Court for a proper determination of jurisdiction and to provide the procedural and

substantive due process to which he is entitled. See U.S. Const. Amends. VI, XIV; Okla. 20, art. II, §§ 7, 20; Evits v. Lucey, 469 U.S. 387, 105 S.Ct. 830, 83 L.Ed.2d 821 (1985); Williamson v. Ward, 110 F.3d 1508, 1522 (10th Cir. 1997); Wilhoit v. State, 1991 OK CR 50, ¶¶ 3-5, 816 P.2d 545, 546-547; 22 O.S.2011, § 1051. Matters implicating the Court's jurisdiction are never waived and can be raised at any time. Id, 2021 OK CR 3, ¶ 21. Therefore, Appellant requests this Court remand this case for an evidentiary hearing on Appellant's Indian status so that the convictions in this case be properly reversed and dismissed.
