

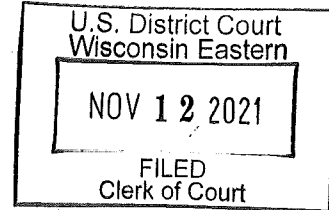

Burr violated my rights by circumventing federal appeal from Stockbridge Munsee
Tribal Court regarding her frivolous claims for harassment and trespass, screened and
and Dismissed. Burr then attempted to re-litigate in Shawano County Court and it was
again Dismissed because of res judicata and barred by collateral estoppel. Instead
of filing an appeal to WIED, (now time barred) Burr complains to BIA Baker because
Burr does not like it, that, her own tribal court Dismissed her claims as frivolous.
Defendant Baker, circumvents the Stockbridge Munsee Tribal Court Decision and
attempts unlawfully evict the Plaintiff by issuing a defunct Notice of Trespass - Order to
Cease and Desist dated Oct. 24, 2021. The incident arises from Plaintiff's Great Aunt
Mae Sarah Jordan property on the Stockbridge Munsee Indian Reservation, WI 54128.

It is known that Defendant Burr lives next door to the Mae Jordan property, and has called the police on the Plaintiff ~ 10 times; police have found no wrongdoing.

Defendant Burr appears to have a mental defect, i.e., rants and raves, harassment by police forcing, also Burr faked an attempted homicide, such that she poured sand around her grill propane tank, photographed it, and called Shawano County Sheriff stating that the Plaintiff tried to kill her and her family, supposedly to gas her or to blow her up. Police dismissed her claim as false. Unsatisfied with the police, she filed a civil suit v. Plaintiff in Stockbridge Munsee Tribal Court for harrasment, trespassing on the Mae Jordan Property. It is Burr's unlawful felonious claim against the Plaintiff that infers that Burr has a mental impairment. Defendant Baker has most likely been lied to and is the cause of BIA Baker's ridiculous attempt to circumvent the Honorable Judge Travis Miller's Stockbridge Munsee Tribal Court Decision, inferring Burr's claim is frivolous. Moreover, the Honorable William Kussel, Shawano County (21cv143) barred Burr as res judicata arising from the Tribal Court Decision. As noted by Judge Kussel the Doctrine of Collateral Estoppel applies. The Plaintiff has the right to due process of law. The BIA does not have the right to circumvent a Tribal Court Decision. The Plaintiff has the right to proper, just, and fair litigation. Burr, the Tribe, and the BIA had the right to to join and Appeal to WIED, but they failed to do so. Circumventing a Tribal Court Decision by making a complaint elsewhere places all tribal court decisions nationally in jeopardy; Decision made invalid just by filing a complaint sets a dangerous precedent.


