Call for Proposals: Volume 24, Symposium Issue

**200 Years Since *Johnson v. M'Intosh*:
The Case's Impacts on Native Communities and Tribal Governments**

- Proposals are due by March 15, 2023
- Notifications regarding acceptance will be emailed by March 31, 2023
 - Article drafts will be due by August 1, 2023
 - Symposium will be held on November 9, 2023

The *Tribal Law Journal* at the University of New Mexico School of Law will host a virtual symposium addressing the impacts of *Johnson v. M'Intosh* on Native communities and tribal governments.

The symposium will bring together students, practitioners, community members, and scholars to discuss Indigenous perspectives on this foundational case of federal Indian law. The discussion also will include the case's adoption of the doctrine of discovery and what this means for Indigenous peoples today. Potential subtopics may include the case's significance in the context of contemporary settings and developments such as the “Land Back” movement and Indigenous activism for protecting Native lands and natural resources. Articles and essays produced for the symposium will be published in a special issue of Volume 24 of the *Tribal Law Journal*.

Conference Structure and Registration

The symposium will be a one-day event and will take place remotely. We plan to have the symposium free and open to the public. CLE credit will be available. More details will follow.

Presentation Formats

The symposium will include a keynote address, multi-speaker panels, and select individual presentations.

Submitting a Proposal

Please submit your proposals via email to tlj@law.unm.edu. Your proposal should include a tentative title and a short summary (100 words or less). The proposal also should include an abstract (750 words or less) that more fully describes your proposed article. In addition, please include your contact information, your organization or institution, and your title and/or position. Finally, please indicate whether you are willing to participate as a panelist at the symposium.

Deadline

The *Tribal Law Journal* will consider proposals that are submitted by email on or before March 15, 2023. All proposals will be reviewed by March 31, 2023. After that, we will notify you if your proposal has been accepted for presentation and submission. If your proposal is accepted, your article should adhere to the format requirements listed below.

Article Format

- Begin manuscript with an abstract of approximately 100 words or less.
- Text should be double spaced, plain font (Courier or Times New Roman), and 12 pt. font size.
- Use one-inch margins top, bottom, left, and right.
- Page numbers should be included at the bottom center of each page.
- Title and author name(s) must appear on the first page of the article.
- First footnote should contain 1-2 sentences of biographical information about the author(s).
- Block quotations should be single spaced, indented one inch from margins and consist of at least 50 words.
- Footnotes should be single spaced.
- Citations must conform to the rules of THE BLUEBOOK: A UNIFORM SYSTEM OF CITATION (21st ed., 2020).
- Tribal code and case citation format should conform to the high court of that particular tribe.
- Tables and figures should have a maximum size of 4.5" × 7" with headings and notes within those dimensions.
