Touro University Jacob D. Fuchsberg Law Center seeks to hire a full-time Assistant Dean for Academic Excellence and Bar Success with faculty rank on a specialized tenure track. This administrator must have significant prior experience in legal education and with academic success and bar readiness programs. The administrator's primary responsibilities will be to: (1) oversee the operations of the law school's Academic Excellence and Bar Success Department; (2) to design and implement programs for students' academic success in law school and (3) to design and implement strategies and programs for graduating students' success on the bar exam. The Assistant Dean will also teach bar readiness courses as needed, and may have the opportunity to teach substantive courses, depending on the needs of the Law Center. The Assistant Dean will serve as an advisor to the Dean and the Associate Dean for Academic Affairs in matters relating to student success in law school and on the bar exam.

A candidate must have a J.D. degree from an ABA accredited law school and a commitment to teaching in an environment dedicated to excellence in teaching and mentoring of students. We look for innovative faculty with a preference for both practice and teaching experience. Applicants must demonstrate a commitment to service to legal education and to the wider community as well as a desire to engage in the intellectual life of the Law Center. With one of the most diverse student bodies in the country, Touro Law Center is dedicated to the aims of diversity and strongly encourages applications from women and minorities. Applicants are expected to be willing and capable of teaching in-person and remotely and be familiar with best practices in both modalities.
